# 2020 Six Year Facility Master Plan

### Kirby School District 2020 Six Year Facility Master Plan Narrative

### Configuration:

The Kirby School District is comprised on an Elementary School (K-6) and a High School (7-12). Both grade levels are located on the same campus and share spaces.

### **Enrollment Growth:**

The enrollment projection summary posted on the Division of Public School Academic Facilities & Transportation (Division) website indicates that future enrollment will rise from 384 students in the 2019-20 school year to 503 students by school year 2029-30. Kirby School District welcomes this increased enrollment and feels that future enrollments could exceed the Division's projections, when Caddo River Lumber Mill in Glenwood, AR, is re-established. This increased growth is creating a need for additional classroom space and a project has been placed on the Master Plan to address this need. Future enrollment data will continue to be monitored in an effort to plan for facility needs.

### **Future Projects**

### Districtwide Fire Alarm Replacement - Partnership Project# 1920-5503-001

The existing Fire Alarm systems are not compatible throughout and are nearing the end of their projected life cycle. The District has an approved, un-funded project pending to address this deficiency. Upon funding approval, all fire alarms districtwide will be replaced.

### Cafeteria Replacement – Partnership Project # 2021-5503-001 The existing cafeteria is in poor condition and inadequately sized f

The existing cafeteria is in poor condition and inadequately sized for the districts 349 student enrollment. This project is to take that facility out of service and construct a new cafeteria for the district. This new facility has been planned at approximately 6,800 SF and will meet all requirements of the POR and School Facility Manual. It will contain 2,780 SF of dining space, 1,262 SF of kitchen space, 1,390 SF of support space, and building services. This project is pending Partnership Project funding approval.

HVAC and Electrical Replacement at the Gym – Partnership Project # 2021-5503-003

The district has a Partnership Project approved / pending funding, for the installation of a new HVAC systems in Gym. This new system installation will require a total electrical replacement of panels and wiring throughout as well new emergency lighting and exit signs. The District has

decided to submit an application for a new High School Multi-Purpose Gym. If that application is approved and funded, this project will be rescinded.

HS Multi-Purpose Gym and Cafeteria Conversion – Partnership Project # 2122-5503-002
The District plans to take the existing gym out of academic service and construct a new Multipurpose gymnasium. This new facility would contain HS classrooms, band, performing arts, and
PE. By constructing these new spaces for the HS, the district is able to utilize the existing
vacated spaces to fulfill the minimum requirements of the POR. The District also plans to
convert the existing cafeteria into a Middle School computer lab and Middle School Career Ed
Classroom. If this project is funded, the District will rescind all Partnership funding for WSD
systems on the old gym. See POR and application for additional notes.

### Districtwide Fire Alarm Replacement - Partnership Project # 2122-5503-001

The District is submitting this application for new fire alarm systems districtwide as an alternate to PP#1920-5503-001; in the event that PP# 1920-5503-001 is funded this project will be withdrawn.

Elementary School / High School Roof Replacement – Partnership Project # 2324-5503-001
The existing roofing system on the Elementary / High School Building is in need of replacement due to condition.

### Depreciated Negative Value Buildings

Gymnasium (-24%) All major building systems are being maintained in an equitable manner through the use of school dude. The district has requested Partnership assistance with replacement of the existing fire alarm, and electrical systems, as well as installation of a new HVAC system in this facility. A new project is being propsed that would take this building out of academic service. If that project is approved all Partnership funding on WSD systems will be rescinded.

Outside Counseling / Parent Center (-20) All major building systems are being maintained in an equitable manner through the use of school dude. This building is being considered for demolition; it is a potential site for the new Multi-Purpose Gym.

Kirby School District is committed to addressing the facility needs within our district and we are grateful for the support of our School Board, community, staff, students, and the Division of Public School Academic Facilities & Transportation.

#### **School Activities**

**Robotics** - 18 students participated in robotics this year. We competed in the BEST robotics competition in November and placed 3rd in robot performance and 5th overall out of 21 teams. We assisted NASA in a satellite program design and received great reviews from them!!

**FFA** - In Animal Systems, students explored hands-on projects and activities to learn the characteristics of animal science and work on projects and problems similar to those that animal systems professionals such as veterinarians, livestock producers, animal scientists, embryo technologists, livestock buyers, animal nutritionists, livestock geneticists, USDA inspectors, meat science researchers and feedlot specialists face in their respective careers. In Power Structure and Technical Systems, students explored hands-on projects and activities to learn the characteristics of agricultural mechanics and work on projects and problems similar to those that power, structural and technical professionals such as machine operators, diesel mechanics, agricultural engineers, heavy equipment maintenance technicians, equipment and parts managers, welders, machinists, electricians, GPS technicians, plumbers and masonry specialists face in their respective careers.

**WOLF Program -** The Kirby WOLF Program is a Workbased Learning experience that is funded through Arkansas Rehabilitation Services. The students all have to meet qualification requirements in order to participate. These students learn soft skills and on the job skills while earning minimum wage for their work hours.

**Chess/Quiz Bowl** - Chess Club had practices on Mondays after school and at lunch breaks. The Club attended both ACA Chess and CAAS Arkansas tournaments this year. We placed 1, 2 and 3 at several of these tournaments. CAAS members received an invitation to State. Quiz Bowl met several times throughout the year.

**UnDirty Dozen -** These students helped with numerous activities throughout the year.

### **School Activities**

**Music -** Kirby Music Department has had a successful year with many performances, field trips, projects and classroom concerts. Mrs. Hainen and her students continue to amaze us with their series of plays, musicals, and concerts. This program is our fastest growing school activity! Our students enjoyed performing for their peers and the community.

# Requirements by ADE due to 40.25 in the In Need of Support Category in reading

Currently, we have met all requirements set forth by the ADE in elementary to address the deficiencies in reading on the ACT Aspire school-wide.

Elementary was 35% percent in need of support and High school was 45% percent in need of support and that averaged per class led to 40.25 % in need of support category, 40% is the threshold.

- A. We have High Quality Instructional Material for next year for K -10. Thanks to the SOAR Grant.
- B. We scheduled 60 minutes for small group instruction and observed these for science of reading requirements.
- C. All schedules have been changed to meet criteria requirement.
- D. All teachers have signed up for updated Science of Reading PD this summer
- E. We are scheduled to meet again with DESE rep and Dawson Team on May 2,2023.
- F. We met with Dawson and are on track with all goals, scheduled on going PD with Dawson and the new reading curriculum companies.

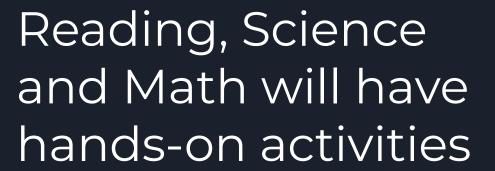

### Things beyond our control

We currently have 75 special education students enrolled in the district. Some of these students have speech only IEPs but most have educational and speech.

We had new students enroll in the last week that were in sped.

17 out of 42 third graders have IEPs.

LEARNS Act- reading on grade level by 3rd grade will put pressure on everyone.

Act Aspire testing is April 17-May 4, with STAR testing for K-2 the first week in May, also.

We pull out students who have accommodations and modifications due to 504s and IEPs, pull out groups are larger than groups that stay in the classroom in some classes!

The new state test will be the ATLAS. We have representatives going to Dawson for an overview of how this will be implemented.

Brandi will no longer do ESOL, but will do counseling each week with elementary students which will be 30 minute sessions for each class. High School sessions with Brandi will be in the afternoon only.

Carson will do Elementary PE and math remediation.

The safety grant will have all areas of the school monitored and locked down.
