- 4. Provide the Athletic Director with a weekly Friday report verifying #'s 1-3 above as well as how many athletes participated in #3.

In the event a 2020 spring coach does not meet all of the responsibilities above each week, their spring coaching pay will remain at 50% of the contracted amount. This decision will be made by the Athletic Director and HS Principal.
