This Document Must Be Signed Before Using any CCS Owned Network, Devices, or Account. Students/Parents Must Renew Signature Every School Year.

Cleveland City Schools seeks to empower students and teachers with the latest technology and resources that enable them to more effectively lead, teach, and learn. However, the use of the school network, accounts, and devices is a privilege. Inappropriate use can result in cancellation of these privileges as well as other consequences.

<ul> <li>Follow board policy and be respectful, responsible, and safe while using all school technology resources.</li> </ul>	<ul> <li>Send, display, request, or attempt to download offensive messages or pictures.</li> </ul>
<ul> <li>Use school devices, accounts, and networks knowing that there is absolutely no expectation of privacy.</li> </ul>	<ul> <li>Bully, harass, insult, defame, discriminate against, threaten, attack, use obscene language, or injure others.</li> </ul>
<ul> <li>Care for the device I am borrowing to prevent loss or damage.</li> </ul>	<ul> <li>Film or photograph others without their consent.</li> </ul>
<ul> <li>Utilize CCS devices for approved and appropriate uses as indicated by board policy.</li> </ul>	<ul> <li>Attempt unauthorized access to the network or resources.</li> </ul>
<ul> <li>Downloading software programs must be pre-approved by the Director of Innovation or designee.</li> </ul>	<ul><li>Bypass filters to access unauthorized websites.</li><li>Damage a device, network, or account.</li></ul>
Only use the device that is assigned to me.	<ul> <li>Use another individual's login credentials or trespass into another individual's account or files.</li> </ul>
<ul> <li>Report any threatening, obscene, inappropriate, bullying, or other offensive behavior to a school representative or supervisor.</li> </ul>	<ul> <li>Reveal personal or confidential information about myself or others (e.g., addresses, phone numbers).</li> </ul>
Only search for or visit appropriate websites.	<ul> <li>Plagiarize, cheat, facilitate academic dishonesty, or violate copyright laws.</li> </ul>
<ul> <li>Follow teachers' and/or administrators' rules and requests with regard to technology usage.</li> </ul>	<ul> <li>Engage in inappropriate uses of video conferencing, text messages, chats, social media, etc. or use these</li> </ul>
<ul> <li>Be kind, courteous, and professional when communicating with others.</li> </ul>	tools in ways that violate the terms of this policy.
Keep my username and password secure.	<ul> <li>Change settings of computers or programs (outside of minor personalizations) or attempt to repair or alter devices or any other equipment.</li> </ul>
<ul> <li>Promptly return the device I am borrowing from Cleveland City Schools upon request.</li> </ul>	Engage with or facilitate any illegal activity.

In addition to this acceptable and responsible use policy, the use of Cleveland City Schools' network, devices, and accounts by employees and students is governed by Cleveland City Schools Board Policy. The following policies are explicit in their definition of uses of technology resources and the consequences of abuse: Use of Internet 4.406; Use of Electronic Mail 1.805; Web Pages 4.407; Use of Copyrighted Material 4.404; and Student Publications 6.704.
