Mr. Michael Burke stated that Thursday was the environmental poster and essay contest. We had two (2) winners for the essay contest and two (2) winners for the poster contest.

Mr. Michael Burke stated that Bark for Education raised over \$3,400. Mr. Burke stated that he wants to publicly thank the CEF.

Mr. Michael Burke stated that Friday will be the memorial ceremony in honor of Ricky Lee. The parent's will be giving out a \$10,000 scholarship for that grade.

Amir Alon & Orly Gal – 8 Kennedy Road wanted to know what are the checks and balances for the special education department and/or programs. Do they meet the education standards? Is there an independent audit done of the special educational programs? Is the staff properly trained for the autistic program? Is it a cost effective program?

Mrs. Denise Villani stated that independent audits of specific special education programs are not done or required by the state. Mrs. Denise Villian state that the Cresskill Board of Education feels that our special education staff provides a quality education for all of our students. All of our staff is properly trained and the program is cost effective. Mrs. Denise Villani went on to state that if they had any specific questions about our special education programs that they must contact Dr. Janelle Amata, our Director of Special Education.

Mr. Eugene Gorfan – 91 Westervelt Place wanted an update on the water situation. Mrs. Antoinette Kelly replied that on June 2, 2016 the second round of water testing was done and at this time those results have not been received. As soon as the results are received we will share them with the community as we did with the first round of testing. Once all the results are received and we review the recommended remediation plans we will begin correcting these issues and plan to have it completed by the start of the new school year.

Mr. Eugene Gorfan wanted to know what is the fund balance for the end of the year. Mrs. Antoinette Kelly replied that she should have a number by the next Board meeting when we approve the June reports.

Mr. Eugene Gorfan wanted to know how we are addressing the Orlando tragedy.

Mr. Michael Burke stated that we are flying the flags at half mast, internal discussion with the Cresskill Police and the teachers are discussing in social studies classes.

Mr. Eugene Gorfan wanted to know if there was a list available showing where the students got accepted into college.

Mr. Michael Burke replied that there is a partial list in my budget presentation. We do not publish a full list but there is a list in the guidance office.

Alba Shick – 27 Churchill stated that she received positive feedback about the orientation.

Ms. Shick stated that the pool party went well.

Ms. Shick wanted to know about the food service program for special needs students.

Mrs. Antoinette Kelly replied that she and Ms. Shick could meet with the H.S.A. and Pomptonian.

Ms. Shick inquired as to when the PARCC results will be in.

Mr. Michael Burke replied they should be in by early fall.

Ms. Shick wanted to know what we are doing with the language program.

Mr. Michael Burke replied that we are going to keep language in the 4th and 5th grades and will modify in the 2nd and 3rd grades.

Ms. Shick wanted to know what we are doing about transgender bathrooms.

Mr. Michael Burke replied that it is in the discussion stage but we have not had a discussion on it as a Board.

Ms. Shick wanted to know what the Option II Program is.

Mr. Michael Burke stated that it 2016-2017 is the pilot program this year. Eleventh grade students have the option to opt out of gym for one marking period (1, 2 or 4th). They are allowed to have a study hall that marking period and would not be able to leave the building and they must meet all the criteria.
