Therefore, in accordance with N.J.A.C. 6A:23-14.1 (i) the district has obtained the commissioner's approval to withdraw funds from capital reserve by establishing that an emergent condition exists necessitating an immediate withdrawal of capital reserve account funds.

Now Therefore Be It Resolved, that the Cresskill Board of Education, upon the recommendation of the Superintendent, authorize the withdrawal of \$50,000 from Capital Reserve in order to replace the communication system at the Cresskill Middle School – High School. In accordance with N.J.A.C. 6A23-14.1 (j)3 the funds will be transferred to the Capital Projects fund and accounted for separately. Any unexpended transferred capital reserve funds remaining after completion of such project, the Board of Education shall return such funds to the Capital Reserve account.

Mr. Eugene Gorfan – Westervelt Avenue wanted to know how much the lead testing cost. Mrs. Antoinette Kelly replied that the first round of testing cost \$2,600 and the second round will cost approximately \$2,600 to \$3,000. The good news is that the insurance company will be covering the cost of remediation but not the cost of testing. The district will need to send the plans to the insurance company first for review before we complete the remediation.
