CALL TO ORDER

The regular Meeting of the Cresskill Board of Education was held on Monday, November 11, 2019 at Cresskill Middle/High School in the Media Center. The meeting was called to order by Denise Villani at 7:00 p.m.

READING OF THE OPEN PUBLIC MEETING STATEMENT:

PRESENTATION

Greenway Project, Stephanie David and Andrew McKesh

The Greenway Project is along an 8 mile section of rail tracks from Tenafly to Northvale. Funding would possibly come from grants, state funds, and/or Green Acres funding. Ownership is still to be determined. Concerns over security and flooding were addressed. The timeline for the project is ten years.

PUBLIC HEARING

Superintendent's Contract

President Villani explained that by statute, renewal/renegotiation of the Superintendent's contract must be advertised publicly. Since the law that capped Superintendent salaries has been lifted, we are seeking to renegotiate Mr. Burke's contract. We are proposing incorporating the available merit bonuses into his salary, which has already been budgeted, and a 3% raise each year after this year. The new contract would be for five years. Trustee Cummings asked how the contract compared to other administrators; President Villani replied that it was difficult to obtain comparable information. Ms. Alba Shick asked if other district's contracts are public, and wanted to know how we could offer Mr. Burke more incentives.

Ms. Delasandro explained these reports are a final accounting of the grant receipts and expenditures. There is rollover money that will be applied to the current year.

Trustee Cummings asked about the Girls Varsity Soccer Coach resigning. Mr. Burke replied that he resigned due to family reasons. Trustee Klein stated that they were hoping the assistant coach would step forward for the position.

Trustee Gorfin asked about the cancelled contract with Agera Energy. Ms Delasandro explained the situation that Agera was in Chapter 11 bankruptcy and rejected its contracts. Cresskill's electric contracts will default to Rockland Electric.

Trustee Klein asked about the School Safety and Security Plan. Mr. Burke replied that he meets regularly with the Cresskill Police Department. Cresskill Police Department can view schools video from cameras in an emergency. The School Safety Plan, which is submitted to the state does not include the police viewing video.

BOARD PRESIDENT'S REPORT

President Villani attended the Marching Band Festival at Montclair State University. She stated that it was a fun event and the performances were great. Much credit goes to Mr. Verderese. The Varsity Boys final soccer game was a tough loss in freezing cold weather that came down to a penalty kick. The boys played their hearts out and it was a great show of class, even in defeat. The Concert for the Arts is next Monday. Congratulations to four board members who were re-elected.

SUPERINTENDENT'S REPORT

Mr. Burke described the Boys Varsity Soccer final game as a "classic Cresskill moment". It came down to penalty kicks and both teams were winners. Cresskill Senior, Jackie Lulaj, set a new Cresskill record in cross-country running. Mr. Burke spoke about dismissal during an evacuation event due to flooding at the high school, which was brought up by Trustee Cusick at the last meeting. He explained in these events, the students can walk home. The 5th grade basketball game is 11/21/19. The Varsity Football team is doing very well and there is a game Friday.

Francis Reiner, 19 Pierce Ave. – Expressed his concerns over the girls' sports teams not being treated equally to the boys' sports teams. The girls Varsity Soccer final game was scheduled for 10/30/19, but at 2:00 pm it was cancelled due to weather. The senior girls ceremony was still held, but in the cafeteria on Wednesday afternoon. He stated this would never have happened to the boys final football game.

President Villani understands his frustration because she also has a daughter who is a student athlete. Alba Shick, 27 Churchill Rd., also has a daughter on the girls varsity soccer team and she was devastated. All sports should be equal, she suggested a special pep rally.

David Spelbrink, 156 South St., asked how is the school going to address the lunch aide issue at MMS? Mr. Burke replied that he is working on it right now. Both lunch and classroom aides are a priority.

Mr. Spelbrink asked when the town time capsule was buried. Mr. Burke replied that the two dates had been cancelled and he was pushing for the dedication at the council meeting.

Ms. Shick stated that her mother was a lunch aide, but \$12/hour was not worth it for 1.5 hours per day. In Englewood the pay is \$20/hour.

Ms. Shick asked who controls the electronic board. She would like to see current information on it. Trustee Cusick stated that she was an athlete and at every home football game her school honored a different sports team. She suggested honoring the girls varsity soccer team at the upcoming home football game. The board agreed with the idea.

TRUSTEE COMMENT

Trustee Gorfin asked to have the district testing presentation posted to the website.

Trustee Klein stated that 55 people attended the Meet the Administrators night. Parents against Vaping presentation will be held on 12/4 at 7:00pm at Merritt Memorial. The HSA will host Comedy Night on January 24, 2019. This is in place of Casino Night and is the major fundraiser for the Association.

Mr. Gorfin stated that the town newsletter had incorrect information regarding the Board meeting dates.
