
Dear SC Chair Reilly,

Dear Medfield School Committee Chair Jessica Reilly,

This is a request for the following documents under Open Meeting Law:

- 1. Draft minutes from the Feb. 10, 2022 Medfield School Committee meeting.
- 2. A copy of documents associated with the most recent Superintendent Evaluation for Jeffrey Marsden (as discussed on Feb. 10, 2022) used at the Feb. 10, 2022 meeting. Records provided should include both the compiled evaluation and each individual School Committee member evaluation. (See supporting reference below.)

According to an FAQ from Massachusetts Association of School Committees: "Are the evaluations of individual members public? Yes. If the individual evaluations are used in the creation of a composite document, they are considered public records."

MASC also cites MA AGO: "The Open Meeting Law states that 'materials used in a performance evaluation of an individual bearing on his professional competence,' that were created by members of a public body and used during a meeting are public records, and cannot be withheld from public disclosure. See G.L. c. 30A, §22(e). Thus, employee evaluations that members of a public body create and then use during an open meeting to evaluate an employee are public records. Comprehensive evaluations that aggregate the individual public body members' evaluations are also public records if they are used during the course of a meeting." https://www.mass.gov/info-details/frequently-askedquestions-about-the-open-meeting-law#frequently-asked-questions-about-evaluations-

Excerpts of individual SC member evaluations shared aloud at the meeting and incorporated into the aggregated document deem the individual documents as "used" during the meeting.


