Introduction

SSDA and PCG are pleased to partner in the administration of this survey of small school districts in California to measure the performance of these districts during the Spring 2020 Coronavirus pandemic. This analysis also reflects needs for District strategic roadmap planning to re-open schools.

We are pleased to report that small school districts operate as education innovators, taking full advantage of the connective, small community nature of their programs to provide premier learning to their students.

Very little media attention has called attention to the rapid and efficient transformations completed by Districts during a time of crisis. The agility and pioneering nature of these schools provide a testing ground for important educational theory design and testing.

By capturing the best practices and ongoing challenges of these schools, conclusions may be drawn that may be of great advantage to all educational organizations.

### SSDA Coronavirus Innovation Survey Background and Methodology

As co-advocates of localized education with community driven connectivity that makes our schools great, we seek through data and collaboration to reinforce all positive school leadership and guide leaders to potential solutions where they find need.

Target Population Studied: California Small School District Superintendents

#### 185 of 546 total California Small School Districts completed survey: 34%

Objective: Measure Small School District performance and concerns resulting from the Coronavirus school shutdown Spring 2020; Collect best practices from Small School District leaders for consolidated best practices framework; assess ongoing threats to 2020 reopening of schools.

#### WINS

- Small Districts were in full instruction within an average of 5.3 days
- 20 schools were able to execute an immediate transition with 0 lost days, 28 started within 1 day
- 81% rate of active student participation
- 70% of respondents reported staying at or above academic achievement levels of expected 2020 goals
- 86% of respondents reported positive management of social and emotional wellbeing

#### NEEDS

- 54% of Districts rated getting access to technology infrastructure as Difficult or Impossible with only 8% reporting the issue as Efficiently Handled
- 88% respondents indicated need for enablement of In-District Capacity for Distance Learning Curriculum Development
- 84% expressed need for Professional Development to guide instructional practices in distance learning
- Administrators expressed a need for guidance in designing hybrid educational plans for reopening: 2.2% considered themselves expert and 16% advanced
- 89% of small Districts revealed serious challenges to reopening due to budget constraints
