R.C.3313.843(F) Service Cost

The Ross Pike County ESD provides a myriad of services for our member school districts.

- 1. The cost of services offered to member districts is based on actual cost divided among our member districts based on a combination of the number of member districts and the districts ADM. The service offered include but are not limited to the following:**

- Professional Development for teachers, administrators and other school staff
- Special Education Administrative Personnel/Consultation
- Curriculum Personnel/Consultation

The above services are on retainer for \$65 - \$165 per day, with annual contract. Price determined by usage measures.

- *Hosting of meetings for superintendents, principals, treasurers and technology coordinators
 - *Representation and coordination with community agencies and programs on districts behalf
 - *Assistance with teacher licensure and Para-Professional Testing
 - *Home School application processing
 - *Autism Awareness Programs
 - *Ohio Department of Education Rollouts
 - *Ross and Pike County Spelling Bees, Math Competitions, and Scholastic Bowls
 - *Summer Learning programs-College for Kids
 - *Business Advisory Counsel
 - *Technology Consultation
 - *Franklin B Walter Scholarships
- *The above services are included as part of the alignment agreement with the ESC, the districts \$6.50 is used to offset cost.*

- 2. Services offered for a set fee include, but are not limited to the following:**

- Roweton Center for court appointed students \$60 per day.
- Fingerprinting \$35 for BCII and \$35 for FBI
- Para-Professional testing \$75
- VLA \$185 License Fee, \$210 for Licenses Fee, \$1000 Annual Participation Fee
- Professional development for non-member districts \$600 per day or established based on individual request.
- Bus Driver Certification \$50 with Adena Health
- Drug Testing \$50, Random Drug Test \$78 with Adena Health
- Truancy Task Force-Parent Education Classes \$1,250
- Resident Educator Program Coordination \$3,000

-The ESC will act as a third party billing service, in which the actual cost is divided among participating districts. (Great Seal Network, Adena Heath Services, Resident Educator Co-op) In some cases a minimal administrative fee will be charged.

- 3. Services offered on a cost reimbursement method (actual personnel cost and actual instructional equipment, materials, supplies and other related cost, plus a 3-5% fiscal Fee) For districts that participate in the cooperative, the cost is allocated by 50% district ADM and 50% percentage of students in the cooperative classroom units. For Speech, Psychology and Truant Officers services, the cost is divided by a combination of participating districts and ADM. The services include but are not limited to the following:**

- Multiple Disabilities Classrooms
- Preschool with Disabilities Classrooms
- Preschool Itinerant Instruction
- Preschool Physical Therapy
- Preschool Occupational Therapy
- Emotional Disturbance Classrooms
- Cross categorical Classrooms
- Direct Classroom Special Education Supervision
- Talent and Gifted Coordinator
- Talented and Gifted Classrooms
- School Psychology
- Speech Pathology
- Truant Officers

Any grants, state funding or fees collected are deducted from the actual cost to the districts.

- 4. The cost of hiring personnel for individual students or positions directly for a school district will be offered at cost plus a fiscal fee, and supervision fee. The services include but are not limited to the following:**

- One on One attendants. Actual Cost, plus 5% fiscal fee and 7% administrative fee
- Direct Position, 3% Fiscal Fee or less.
