Parents will be invited to be on the Parent Engagement Committee to help plan and develop improvement throughout the school year. During these meetings, we will discuss ways to get parents involved and engaged in their children's education.

During the parent engagement meetings, parents will be given the opportunity to provide feedback on fun, interactive, and educational events.

The school will communicate with the members of the committee through email, unless parents decide on an easier and faster way. This committee will be a voice to all parents.

Parents from the committee will help inform other parents about their rights and create special events for Title I meetings.

All teachers will send information through each child's folder and\or digitally every day in regards to behavior, homework, school work, and events.

Teachers are in contact with parents throughout the year via notes, phone calls, and conferences. The school will use the Dojo app that sends messages to the whole class in regards to school information or to messages to parents. It also keeps the parent informed about their child's behavior that day.

Ridge Road has a Facebook page that regularly announces information about events, testing, school rules, and unexpected events that might alter the regular school day.

Report cards go home every nine weeks with interim reporting every four to six weeks.

A STEAM night, Art Night, and cultural celebration nights, will be scheduled once a year to increase parental involvement in supporting classroom instruction.

Teachers have been trained in trauma-informed care and PBIS

Throughout the school year, teachers will receive educational videos, information, and opportunities to attend training in regards to helping to build their capacity to work with parents as equal partners.

During certain staff meetings (based on parent engagement committee needs), we will discuss and educate our staff on the importance of parent relationships.

A Parent Center is located in the library and office. The library houses educational resources for the parents to check out regarding student needs. Funds are provided each year to maintain this center.

Parents will be informed of this parent center through the teachers, apps, and through word of mouth.

The Principal, Matthew How, ensures that the beginning of the year packets are sent home with each student and/or posted virtually. This packet includes information about our school, the teaching staff, the student handbook, and other general information to get the year off to a successful start.

Educational classes throughout the year for parents and teachers to sign up will be provided throughout the year. Some of the educational classes will be CPR, First Aid, Medicare/Medicaid, etc.
