At 5:00 p.m., Mr. Chapman called the meeting to order noting that all board members of the Board of Education were present along with staff members, Davies, Frederick, Rowehl, Smiley, Wichser, Kawlewski, and Lofy. Parents present were Le, Kidwell, Lebak, Trybula, Mrs. Lofy, and Ziervogel. Also, present was Mr. Hajewski from Baird. Mr. Chapman led those in attendance in the Pledge of Allegiance and noted that the meeting was properly posted.

3. Approval of Minutes- March 17, 2022 Board Meeting

Mrs. Wolski made a motion to approve the March 17, 2022 Board minutes. Mr. Broz seconded and the motion carried on a 3-0 voice vote.

4. Public Comments from Citizens:

The Geneva Jt. 4 – Woods Elementary School Board of Education has provided an opportunity to members of the public to comment on **agenda items**.

The Board of Education is unable to comment on agenda items raised by the public in order to remain in compliance with the State of Wisconsin Open Meetings Law.

Mrs. Trybula shared with the Board her concerns regarding losing students/families. Mrs. Trybula wanted to know what we were doing to address this issue.

a. District Administrator

i. Survey Results

Mrs. Davies shared the results of the survey that went out to families, asking by email or paper regarding what they like about Woods School and what parents would like to see in the future. There were positive responses. Mrs. Davies shared that the Donovan Group has been helping with setting this up.

ii. Election

Mrs. Davies provided information regarding the election and how we had been following laws for a 6-7 Board member instead of 3. We sought Information from lawyers and state attorneys. The Board wants Mrs. Davies to bring in the attorney's for the next Board meeting to work with the school.

b. Director of Financial Services

i. Financial Update

Mrs. Frederick shared that Lorraine Briere will be starting May 9th, as the Financial Advisor. Mrs. Frederick will be working with her until July 1st and then as needed.

ii. Referendum discussion- Todd Hajewski, Baird

Mr. Hajewski presented options with the Board on District Financial Data, Demographics and Comparables in preparation for a possible referendum. After much discussion from the Board to Mr. Hajewski and Mrs. Frederick the Board asked that we move forward to go to a possible referendum in November, 2022.

Mr. Rowehl shared that we had two bids for grass cutting. Due to some issues with last year's company, we went with the previous grass cutting company, Barajas Lawn Care.

c. Professional development contract CESA 6

Mrs. Wolski made a motion to approve the CESA 6 Professional Development Contract. Mr. Chapman seconded and the motion carried on a 3-0 voice vote.

d. Interactive White Board purchase

Mrs. Davies and Mrs. Frederick shared information on the Interactive White Boards. Smart Boards are not all working correctly. The Board would like to preview them before making a purchase. Mrs. Davies will try and have one at the next Board meeting.
