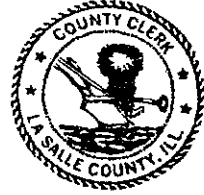

To: Elementary & High School Officials

There has been a change for filing petitions for all the schools for the Consolidated Election. Individuals will bring their petitions to file with the County Clerk's office during the filing period that runs from December 15<sup>th</sup> - December 22<sup>nd</sup>, 2014.

The first day that candidates may circulate petitions for signatures for various offices that will be at the April 7<sup>th</sup>, 2015 Consolidated Election is September 23<sup>rd</sup>, 2014.

Petition kits will be available in my office beginning September 23<sup>rd</sup>, 2014. As a courtesy, I am enclosing the appropriate information and forms, so that you may provide the information to the prospective candidates if you choose to do so. The forms may be reproduced for distribution. Should you distribute petition kits to prospective candidates, it is important that you remind them that the Statement of Economic Interest must be filed in the County Clerk's office and that the receipt for filing must be attached by 5:00 p.m. on the last day for filing (December 22<sup>nd</sup>, 2014).
