A. Project proposals will be submitted by the staff members in the school district. Other projects may also be submitted for consideration by the Foundation from individuals, groups and businesses. Support will be given to projects that enhance, rather than duplicate, existing educational programs.

Q. WHO DETERMINES HOW THE FUNDS WILL BE SPENT?

A. The Foundation leadership will make spending decisions, a board of directors made up of local citizens interested in education.

Q. IS MY CONTRIBUTION TAX DEDUCTIBLE?

A. Yes. Your contribution to the Community Unit No. 2 Foundation For Education, Inc. may be treated as a charitable deduction for federal income, gift, and estate tax purposes.

Q. MAY I DESIGNATE HOW MY CONTRIBUTION IS TO BE SPENT?

A. Yes. The Foundation will consider both restricted and unrestricted contributions as well as endowment funds and donations for specific projects.
