Motion to employ Samantha Watkins as a speech and language pathologist for the District for the 2016-2017 school year, pending all paperwork requirements was made by Myer, seconded by LaRock. On roll call, all present voted "aye". Motion carried.

Motion to approve a leave of absence for Lee McLennan from August 9 through August 31, 2016 was made by Susan McNelis, seconded by Don McNelis. On roll call, all present voted "aye". Motion carried.

Motion to approve the Serena High School golf co-op with Newark High School, as presented was made by Thompson, seconded by Susan McNelis. On roll call, those present voted "aye". Motion carried.
