A. Continuity of Learning Plan Update

Deb provided an update. Food delivery through June 4. Report cards home with food delivery the week of June 1-5.

Currently in phase 3. Moving to phase 4. Includes work to have a safe re-entry into school in the fall. We are already surveying our families. Teachers are making phone calls to all students/parents regarding internet connectivity.

Phase 4 details must be ready for submission and approval by June 30.

Suggested to have 3 different plans for the fall. We will need to grade and assess in the fall whether on campus or online.

BUDGET – There will likely going to be a supplemental reduction or a proration to the 19-20 per pupil allocation, which is currently \$8111.00. This decision has not been made. A supplemental would be favorable because a proration resets the foundation and then an additional reduction would be on the new, reduced foundation. There is new talk of the total cut to be around \$1150 cut per pupil for next school year. This is preliminary information and nothing has been decided by the state. Per MASB, \$3T stimulus will NOT pass. Estimated bounce-back is the 2023-2024 school year.
