IN THE NAME OF *The Commonwealth of Massachusetts*, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the **Memorial Town Complex** in said East Brookfield on **Monday** the **18<sup>th</sup>** day of **November** next at **7:30** p.m., then and there to act on the following articles:

*Article#1 – Article #1 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$12,000 from available funds to the Technology Equipment Purchases account or take any action relative thereto*

*Article #2- To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$30,000.00 from available funds to the Life & Health Insurance account or take any action relative thereto.*

*Article #3 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$15,000.00 from available funds for a VFD purchase/Installation or take any action relative thereto.*

*Article #4 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$75,000.00 from available funds for a Water Department Stand-by generator or take any action relative thereto.*

*Article #5 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$75,000.00 from available funds for Hiring a consulting engineer for future capital projects or take any action relative thereto.*

*Article #6 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$10,000.00 from available funds for Piping, Meter, chemical feed pump and associated hardware & wiring for West Street Well or take any action relative thereto.*

*Article #7 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$5,000.00 from available funds to the Water Department Standpipe Maintenance Account or take any action relative thereto.*

*Article #8 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$48,000.00 from available funds to purchase a Water Department Utility body truck and plow or take any action relative thereto.*

*Article #9 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$321.00 from available funds to the Treasurer Clerical Wages account or take any action relative thereto.*

*Article #10 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$32,068.59 from the 100th Anniversary Stabilization account to a 100th Anniversary Celebration expense account or take any action relative thereto.*

*Article #11 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$6575.00 to purchase an M.P.H. Industries, Street speed trailer or take any action relative thereto.*

*Article #12 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$5400.00 to purchase a Town clerk new voting machine or take any action relative thereto.*

*Article #13 – To see if the town will vote to transfer the sum of \$691.00 to the Selectmen's professional & technical account for a prior year bill or take any action relative thereto.*

*Article #14 - To see if the town will vote to accept the provisions of Chapter 44, section 53F1/2 of the M.G.L. establishing Water Department as an enterprise fund effective fiscal year 2021 or take any action relative thereto*

*Article #15 – To see if the Town will vote to accept M.G.L. Chapter 64N Section 3 to impose a local sales tax upon the sale or transfer of marijuana or marijuana products by a marijuana retailer operating within the town to anyone other than a marijuana establishment at a rate of 3% of the total sales price received by the marijuana retailer as consideration for the sale of marijuana or marijuana products, said excise to take effect on the first day of the calendar quarter commencing at least thirty days after such vote of Town Meeting.*

Article #16 - To see if the Town will vote to approve the \$450,000 borrowing authorized by the Spencer-East Brookfield Regional School District, for the purpose of paying costs of the feasibility study of David Prouty High School, 302 Main Street, Spencer, MA, and for which the District may be eligible for a school construction grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended at the direction of the School Building Committee. The MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any study costs shall be the sole responsibility of the District and its member municipalities: Any grant that the District may receive from the MSBA for the Study shall be as set forth in the Feasibility Study Agreement that may be executed between the District and the MSBA; or take any action relative thereto

Article #17 – To see if the town will vote to raise and appropriate, borrow or transfer the sum of \$15,000.00 to a South Pond QQLA Alum treatment; contingent upon all area towns coming up with full funding; or take any action relative thereto.

Article #18 – To see if the town will vote to accept the provisions of MGL Chapter 41, Section 111F or take any action relative thereto.

AND YOU ARE DIRECTED TO SERVE THIS WARRANT, BY POSTING UP ATTESTED COPIES THEREOF, AT THE TOWN HALL, POST OFFICE and PODUNK CHAPEL IN SAID TOWN, FOURTEEN DAYS AT LEAST BEFORE THE TIME OF HOLDING OF SAID MEETING.

HEREOF, FAIL NOT, AND MAKE DUE RETURN OF THIS WARRANT, WITH YOUR DOINGS THEREON, TO THE TOWN CLERK, AT THE TIME AND PLACE OF MEETING, AS AFORESAID.
