Process:

Leading up to three three nights of onsite collaboration, extensive needs assessment was completed and shared with committee members. Needs assessment consisting of data analysis, evaluation, and reflection, was the basis for determining the district's priorities. In each of those areas, the committee continued its work to identify SMART goals (specific, measurable, attainable, relevant, time bound) with specific strategies and action steps for completion. Leadership determined a funding source and a responsible party for each, along with a monitoring plan/timeline. Goals are aligned with MSIP 6 standards & indicators and other district plans (for example: assessment, professional development, Title I LEA, building improvement, etc.). The CSIP Committee will review/update the plan and present it to the School Board quarterly.
