We will most likely be taking part in the joint public hearing this year as our tax asking will be more than the allowable 2% to do the renovation/addition on the high school. Mr. Otten will continue to work with Tobin and Jacob to provide solutions and financing options. Our state aid increase was discussed and an update on legislative issues was given.
