Item 1: Call to Order

NEW BUSINESS

Item 2: Discussion of Rock Building

Superintendent presented two options provided by DESE Facilities.

- 1. Rescind the Partnership Funding for the PHS Building Project. We would not accept the \$5million plus that State was providing. We have the chance to reapply for Partnership Funding for the 2025-2027 cycle. The application would be submitted in March 2024. The caveat to this option is that the State (DESE) will come in and review the high school facilities to approve use of buildings for students.
- 2. Keep the PHS project going with the current Partnership Funds. We can ask for a 6 month extension and not have to have a signed contract with construction by November 2022. This would put off the project until May 2023. We would still be moving forward with the current bldg project. If we needed more time in May, we could request another 6 month extension.

Jim Toney made a motion to table a decision concerning the PHS Building Project and wait to see if there would be additional funding from DESE after the June Legislative session. Mike Davis seconded the motion. The board voted 2-3. Motion did not pass.

On a motion by Gary Cole, seconded by Judy McClain, the board voted 3-2 to approve the Superintendent's recommendation of Option 1 from above.
