EARLY GRADUATION REQUEST FORM

Dear Parent/Guardian:

Your son/daughter has voiced interest in early graduation from Central High School. Approval by parent/guardian is essential for early graduation, and conferences with your child's assigned School Counselor and an Assistant Principal must happen in order for any early graduation request to be approved by the Superintendent of the Aberdeen School District.

The Administration and School Counselors at Central High School want to make sure all students are aware of the options, possibilities, and possible struggles regarding early graduation, such as:

- All of the public universities and technical schools in South Dakota offer Dual Credit courses to **eligible** juniors and seniors. These are college courses that high school juniors and seniors can take at a reduced fee.
 - If a student is eligible to take Dual Credit courses, early graduation would prevent the student from taking advantage of the discounted tuition
- Central High School offers many Career and Technical Education (CTE) courses by which high school students can develop a marketable skill
- Central High School offers Internship opportunities for students to explore a career field
 of interest and learn first-hand what that career is all about. This can help students in
 making future career decisions
- It looks good on post-secondary and scholarship applications when a student fulfills eight (8) semesters of high school enrollment
 - Especially when some applications specifically ask student's to provide second semester schedules with the application
- Early graduates forfeit the right and privileges accorded to the full time Central High School student, such as participation in athletics, clubs, debate, theater, music, prom, etc.

If you feel it would be to the advantage of your son/daughter to graduate from Central High School at the end of seven (7) semesters, as long as the minimum graduation requirements are fulfilled, please complete the following application.
