Site-Based Decision-Making Council (SBDM) ***Parent Member Election Information***

In Kentucky, each school has a governing site-based decision-making council (SBDM) comprised of the principal, three elected teachers, and two elected parents who analyze and create the policies and procedures that govern daily school operations.

It is once again time for parent nominations and elections for the 2020-2021 academic school year. The parent members of the council are elected by the legal guardians of students, receive subsequent training, and serve one-year terms. Any adult who is the legal guardian of a Stanford student is eligible to serve, and all parents are encouraged to attend monthly meetings and actively engage in school functions and activities.

For the 2020-2021 school year we have 2 seats to fill for our SBDM Council. The persons elected will serve beginning now to June 2021.

VOTING: The election will be held on Wednesday July 29 via the school website. A link will also be posted on Facebook. To vote you will need the last 4 digits of your child's Student ID number (found in infinite campus). If you do not have internet access, please call the school to arrange in person voting.

RESULTS: The 2 nominees with the most votes will be announced and notified on or before Friday July 31, 2020.
