<b>Classes</b>	<b>Course Offerings</b>
<ul style="list-style-type: none"> <li>• Classes will be taught by Warren Township teachers.</li> <li>• Daily schedules/agendas will be provided to students.</li> <li>• Students can expect to be engaged in virtual instruction and/or learning activities for a full school day.</li> <li>• The same curriculum used in the classroom setting will be used in the Virtual setting. Students will receive workbooks, materials, etc.</li> <li>• Breakfast and lunch will be offered to Virtual Students who desire it.</li> </ul>	<ul style="list-style-type: none"> <li>• WCHS’s course catalogue is large and there may be limitations to some specialized courses. Courses may be offered on a limited basis and some will be made available through other Indiana licensed teachers. Availability will be contingent on the number of students requesting a course virtually and availability of Warren teaching staff.</li> <li>• Students will work with counselors to identify classes needed and available and create a schedule.</li> <li>• Breakfast and lunch will be offered to Virtual Students who desire it. Details to come.</li> </ul>
<b>9 Week Commitment</b>	<b>One Semester / 18 Week Commitment</b>
<ul style="list-style-type: none"> <li>• It is important to have a consistent learning experience and for students and have time to learn and practice their new routines and procedures for Virtual Learning. We are asking that families who chose Virtual Learning K-8 commit to a full 9 weeks in this model.</li> </ul>	<ul style="list-style-type: none"> <li>• High school courses are designed for 18 weeks (one semester) of instruction for students to obtain credits in the course, therefore students in grades 9-12 who choose virtual learning must commit to a full semester, 18 weeks minimally.</li> </ul>
<b>Considerations</b>	<b>Courses that Require Labs/In Person Direct Instruction (WCC)</b>
<ul style="list-style-type: none"> <li>• Students need support with setting up structures for learning. Having a “coach” at home to help facilitate and monitor their schedule helps students learning from home be more successful.</li> <li>• iPads and Chromebooks issued by MSD Warren will be used for instruction. We will communicate a time and location for Virtual families to come and pick up devices if they need one and to provide device-support as needed.</li> </ul>	<ul style="list-style-type: none"> <li>• Dual credit, CTE and other uniquely scheduled students have requirements that must be met in person to earn college credit and/or industry certifications. Students who are in these programs and can provide their own transportation, may be able to attend their required curricular programming in person based on a scheduling agreement with the administration, course teacher and student.</li> </ul>
