

LINCOLN PARISH SCHOOLS STRONG START PLAN 2020-2021 UPDATED AUGUST 14, 2020

The Strong Start plan includes information about teaching and learning, transportation, sanitation, meals, and athletics in each phase of reopening (Phase 1, Phase 2, or Phase 3), as established by the governor or as deemed necessary by the superintendent.

If the local governing authority of Lincoln Parish or other municipality has established a more restrictive phase of reopening, Lincoln Parish Schools will conform to the more restrictive requirements in accordance with BESE policy.



Registration

We are currently registering for Pre-K and kindergarten. There are limited spaces available for our Pre-K program, so parents should sign up as soon as possible. Parents may come by the Lincoln Parish School Board office to register their child or can print and complete the registration form from the links below.

If you have had a change of address or need to enroll into Lincoln Parish Schools, it is necessary for you to come to the central office to have this processed through us.

Parent prep days will be held August 13, 14, 17, 18. Each school will schedule times for parents to come. Parents are encouraged to attend to sign required documents and learn more about the school year.

LEARNING OPTIONS

Pre-K-12th grade students and their parents have two options for returning to school:

- Lincoln Parish Schools Virtual Program
- In-Class Learning

Lincoln Parish Schools Virtual Program

The virtual learning program is designed for students who do not yet feel safe returning to the classroom. The program will be administered through Google Classroom. Teachers will upload video lessons and instructional materials to this platform for students to engage with. Google Classroom allows students to send and receive communications with the teacher and participate in asynchronous classroom activities. Any lesson recorded during classes will be of teachers only. Parents and students are asked to commit to a 9 week period before making a switch back to inclass learning. Honors, AP, and dual classes are available to those participating in the program.

- Pre-K-5th grade students will have live face-to-face instruction along with prerecorded lessons with assignments and activities. Parents are strongly encouraged to make every effort to have their child available for the live sessions. Live, face-to-face interaction is imperative in helping younger children learn to read and write. Attendance will be based upon completion of assignments.
- 6th-12th grade students will log in to Google Classroom and complete daily assignments at the time of their choice each day and will be counted in attendance as long as their assignments are completed that day. Teachers will embed pre-recorded lessons (in some cases, segments recorded during the live, face-to-face instruction) and slides into Google Slides to help guide the student along in the lesson plan.

Students participating must have reliable internet access and a virtual learning device. The device will be provided at no cost by the school district. Students will also have access to necessary textbooks and collateral materials, which will be provided by the district. Parents will need to provide basic school supplies, such as pencils, paper, etc.

It should be noted the virtual learning is not best for every student. Student placement determinations should take into consideration a student's unique academic, social, emotional, familial, and medical needs of a student, as identified by the student's parent or custodian.

LEARNING OPTIONS, CONTINUED

In-Class Learning

In-class learning will look different for the 20/21 school year. In order to keep our schools and students safe we have administered some changes to the way we will hold classes and operate daily.

In-class learning schedules will be dependent upon the grade that each student is in.

- Pre-K-6th grade students will remain in static groups. Virtual learning program will help create smaller class sizes to also help limit the amount of contact. Students will be given mandatory seat assignments, and each class will have a certain area of the play ground to use during recess.
- 7th-12th grade student group size will be limited to 25 regardless of phase. Each school will maintain consistent seating arrangements throughout different class assignments.

Masks will be required for 3rd-12th graders and are optional for Pre-K - 2nd graders. Masks should be solid colors or may have the school logo. We recommend younger students have their names written inside the mask so they will not get mixed up with others. One cloth mask will be provided to everyone at the start of school. Students and teachers who have medical conditions that are hindered by a mask will not be required to wear one. We will allow "mask breaks" throughout the day when students are spaced and it is safe to do so.

We have updated the school supply lists on each school's website and the Lincoln Parish School Board website. Also, principals will be sending information to parents regarding supplies and when/where to bring them.

TEACHING AND LEARNING

Maximum Group Size: 10 including adults

- All personnel report to support teaching and learning.
- Students receiving Special Education services and Section 504
 accommodations will have options for in-person learning some
 days each week.
- Students with no internet access may have options for in-person learning.
- All other students participate in virtual learning.

TRANSPORTATION

All Grades

Maximum school bus capacity will be 25% including adults.

- School bus passengers ride one per seat with every other seat empty.
- Members of the same household may sit in the same seat or adjacent seats with an empty seat between household groups.
- Every bus rider will be required to wear a mask.
- Each bus will be equipped with hand sanitizer and extra face masks.
- Windows will be let down for the duration of the route to encourage air flow.
- Each bus will be cleaned after the completion of each route.
- Buses will be required to have a mandatory seating chart.

SAFETY

- Schools are closed to non-essential visitors in accordance with BESE policy.
- Every class will be required to have a mandatory seating chart.
- Students and staff are required to wash hands upon arrival, every two hours, before and
 after eating, before and after using outdoor play equipment, and upon exiting the
 building.
- Schools will establish an area and a protocol for isolating sick students. This area will be cleaned thoroughly after the student has gone home.

- Students report to school Monday through Friday.
- Students in virtual program may choose to remain in program.

- Buses will be required to have a mandatory seating chart.

SAFETY

STRONG START FAQ

HEALTH AND SAFETY

- Q: Will I be notified if a student tests positive for COVID-19 in my child's class?

 A: You will be notified if your student is considered close contact with an infected student.

 Close contact is defined by the CDC and Louisiana Department of Health as being closer than 6 feet for 15 consecutive minutes. If your student is considered close contact, the CDC and LDH recommend your student quarantine at home for 14 days. We will follow the recommended guidelines case by case.
- Q: What if my child tests positive for COVID-19?

 A: If a child tests positive, the CDC and LDH requires students to isolate for at least 10 days.

 A student may return to school once they are asymptomatic and have not run a fever for at least 24 hours without a fever reducer.
- Q: What symptoms mandate my child to stay home?

 A. If your child is running a 100.4 temp or higher or has a cough or shortness of breath, it is mandatory that your student does not come to school.
- Q: Will parents have an opportunity to meet teachers in person?

 A: Yes, August 13,14,17,18 have been set aside to give parents the opportunity to meet with their child's teachers. School's will designate times for parents to come and learn how school will look for their child and fill out any required paperwork.
- Q: Who continues class if a teacher is in quarantine?

 A: If a teacher has to quarantine or becomes ill, their class will be covered. Subs will be called upon as usual. In some cases, teachers will still be able to provide instruction from home virtually. We will encourage teachers to partner with someone to assist in the event one of them needs to be home.

SCHOOL OPERATIONS

O: Will students still have P.E. and recess?

A: Yes, we will. However, this will look different at each school from what we're used to. We will maintain CDC and LDH guidance while participating in these activities. Students will remain with their groups. Playgrounds may be sectioned off so that each class may play on different pieces of equipment. P.E. activities will be limited to each class, and all equipment used will be sanitized after each class.

Q: Why do Pre-K - 6th grade students go to school every day while 7th-12th grade students go every other day?

A. Pre-K - 6th grade students will stay with the same group for the entire day, and this will limit the amount of contact they have with other students. We are hopeful the virtual learning program will create smaller class sizes. 7th-12th grade students, however, rotate classes. This will allow us to lower the amount of students per class and in the hallways during class change.



STRONG START FAQ

- Q: If a student has to quarantine or isolate will they still be able to attend class?

 A: Yes, the benefit of a hybrid learning model gives us the opportunity to teach students virtually when they are unable to come to class. Students will be given class assignments and work they can do from home.
- Q: How will the A/B Schedule for 7th-12th grade work?

 A: Each group will come every other day. So, for one week, Group A will come M/W/F and Group B will be T/TH. The next week, the groups will switch. Group B will come M/W/F and Group A will come T/TH. This lowers the number of students in each class and in hallways. Students will be given assignments to complete on the days they are at home, so they will receive lessons all 5 days of the week.

SPECIAL EDUCATION

- Q: How are you handling self-contained students with disabilities at all schools? A: Virtual Program/Hybrid
 - Students with significant disabilities will utilize the Unique Curriculum remotely. The Unique Curriculum has unit lessons that define three levels of differentiated tasks to accommodate the diversity of learners with significant disabilities.
 - Self-Contained teachers will schedule Zoom/Google Meet sessions to follow up on lessons and work on IEP Goals.
 - Service providers (OT, PT, Speech, APE) will provide services to students via Zoom/Google Meet sessions and/or face-to-face. This will be decided on a case by case basis depending on your child's specific needs and IEP goals.
- Q: Will the same school nurse take care of special education students and students showing symptoms?
 - A:Each school will have a school nurse. Universal precautions are adhered to by each nurse with every student. The school nurse is responsible for the health and well-being of all students in the school system. An isolation room or area is designated at each school for those students with symptoms of COVID-19. The practices of social distancing, hand washing/hygiene, face covers and proper PPE will be maintained by the school nurse.
- Q: If the nurse has been exposed how can she work with special education students or others? A:Each school will have a school nurse each day at the school. All school nurses will be adhering to, training students and staff, and promoting the guidelines of social distancing, handwashing/hygiene, face covers and appropriate Personal Protective Equipment (PPE). The Office of Public Health will determine possible exposure and requirements of individual as far as quarantine/isolation as stated in the School Reopening Guidelines from The Louisiana Department of Education. Nurses will be using PPE which should be changed after coming in contact with possible COVID-19 cases.

Q: What happens if your child has autism?

A. Their services will be provided according to their specific needs and IEP goals as with any student with a disability; however, we anticipate there may be some unique needs such as difficulty wearing a mask, difficulty with understanding our new social boundaries, or difficulty with transitioning. The IEP teams should consider these things and include strategies to assist these students in learning new routines. We would also expect the school staff to understand it may take these students longer to adjust and use patience and reteaching of expectations frequently.

Q: How will therapy be done with students with disabilities?

A: If the student is in school, they will continue to receive therapy as normal. If they are hybrid or virtual, it may be offered virtually or the student may have designated times to come in for therapy. This will be determined through the IEP based on the student's IEP goals and specific needs.

- Virtual Students with Disabilities
 - All special education students will receive services according to IEP Goals to the best extent possible.
 - Service providers will schedule Zoom/Google Meet sessions with students in accordance to IEP Goals and service minutes.
- Hybrid Students with Disabilities (6-12)
 - All special education students will receive services according to IEP Goals to the best extent possible.
 - Service providers will schedule either face-to-face or Zoom/Google Meet sessions with students in accordance to IEP Goals and service minutes.
- In Class Learners
 - All special education students will receive services according to IEP Goals in the same manner as previous years.
- Q: How will IEPs/IAPs be done for Virtual Program and Hybrid?

A:IEP Teams will conduct meetings when school reopens. The Team will follow the normal IEP process/protocol for review of IEPs due to participation in the virtual program. IEPs can be amended in the fall to reflect changes needed for 2020-2021 school year. Parents are welcome to attend in person; however, we will also continue to offer the option to attend via Zoom to allow for physical distancing and decreased contacts if the parent agrees to that modality.

Q: What happens if your child has autism?

A. Their services will be provided according to their specific needs and IEP goals as with any student with a disability; however, we anticipate there may be some unique needs such as difficulty wearing a mask, difficulty with understanding our new social boundaries, or difficulty with transitioning. The IEP teams should consider these things and include strategies to assist these students in learning new routines. We would also expect the school staff to understand it may take these students longer to adjust and use patience and reteaching of expectations frequently.
