



Excellence Pass

This opportunity is for seniors who qualify for demonstrating both personal and academic excellence. A qualifying senior may be released from the building during PIE, 2:30-3:15. All seniors are expected to attend homerooms the first day of each week. Special events, change in schedules or exams may alter PIE schedules. Students are expected to attend class when these circumstances adjust PIE days and times.

Applications must be submitted **each quarter** for approval from your homeroom teacher and principal. They have absolute and final authority on who qualifies for a release. Students may elect to be off campus or remain in PIE. Students **MUST** remain in the designated place for the entire period. An Excellent pass may be revoked at any time.
