

American Academy of Pediatrics (AAP)

Key Principles in Guidance for School Reentry

- Ensure policies are flexible and respond to new information.
- Revise/adapt strategies depending on the level of viral transmission in the school and throughout the community.
- Ensure policies are practical, feasible, and appropriate for child and adolescent's developmental stage.
- Consider accommodations needed to support vulnerable populations, with the goal of safe return to school.
- Exclude no child from school unless required in order to adhere to local public health mandates or because of unique medical needs.
- Support the overall health and well-being of all children, adolescents, their families, and their communities.

State Public Health Leaders

July 11,2020-

Dr. Joan Duwve, DHEC Public Health Director:

"Our state is in a dire situation and we will continue to mourn the loss of parents, grandparents, children, friends and neighbors until each and every one of us steps up to do what is right, not just for ourselves but for others. No one is immune to this deadly disease, but we each have the power to impact the path this pandemic takes in South Carolina. Choosing to wear a mask and maintain physical distance today will not only help change the course of the pandemic in South Carolina, it will help save the lives of those around us."

July 12, 2020

Dr. Bell, State Epidemiologist:

"We continue to see more and more young people, especially those under 20, contracting and spreading COVID-19, and we know MIS-C is a threat to our youngest South Carolinians," said Dr. Linda Bell, State Epidemiologist. "MIS-C is a serious health complication linked to COVID-19 and is all the more reason why we must stop the spread of this virus. Anyone and everyone is susceptible to COVID-19 as well as additional health risks associated with it, which is why all of us must stop the virus by wearing a mask and stay six feet away from others. These simple actions are how we protect ourselves and others, including our children."

CONSIDERATIONS Social Distancing

AAP: "Evidence suggests that spacing as close as 3 feet may approach the benefits of 6 feet of space, particularly if students are wearing face coverings and are asymptomatic."

SCDHEC: "To the extent possible, maintain at least six feet of distance between each person."

CDC: "To practice social or physical distancing, stay at least 6 feet (about 2 arms' length) from other people who are not from your household in both indoor and outdoor spaces."

CONSIDERATIONS Cloth Face Coverings

AAP: "Evidence continues to mount on the importance of universal face coverings in interrupting the spread of SARS-CoV-2. Although ideal, universal face covering use is not always possible in the school setting."

SCDHEC:Everyone should wear a <u>cloth face cover</u> in public settings and when around people who don't live in your household, especially when other <u>social distancing</u> measures are difficult to maintain. Continue to keep about 6 feet between yourself and others. The cloth face cover is not a substitute for social distancing.

CDC:COVID-19 spreads mainly among people who are in close contact with one another (within about 6 feet), so the use of cloth face coverings is particularly important in settings where people are close to each other or where social distancing is difficult to maintain.




How do you feel about your child returning to school in August?


How do you feel about your child wearing a face cover at school?






Select the way your child has access to Internet at home.




How do you feel about returning to school in August?


How do you feel about wearing a face cover/ shield at school?



Traditional Scheduling

In this scenario, health guidelines and facility considerations allow for all students and staff to return to a school building to open the school year and during the calendar year.

Reopening Decision Tree AccelerateED Task Force

Medium

Hybrid Scheduling

In this scenario, only a portion of staff and students can report to a physical school building due to a combination of health requirements and facility/space limitations. As a result, some students will be able to report to school while others will have to engage in distance learning.

Hybrid Schedule

- Students are being divided into two cohorts, called Group 1 and Group 2
- •Siblings will be grouped together, regardless of which school they attend
- •Group 1 will report on Mondays and Thursdays
- Group 2 will report on Tuesdays and Fridays
- •Every Wednesday will be a virtual learning day (also used for deep disinfecting on each campus)

Full Distance Learning

In this event, districts should rely on a full distance learning schedule until the health situation permits a return to in-person instruction for all or part of the students in a school.

eLearning and Learning Management System (LMS)

- •We are contracting with STEM Centers SC to offer professional development on best practices for eLearning beginning the week of Aug. 3; this is ongoing PD and there will be follow-up throughout the school year
- •STEM Centers SC will also provide more prescriptive PD to our teachers in the Newberry ONE program
- •We are using the Schoology platform for our LMS
- •This platform will enable us to...
 - -provide students with a personalized experience.
 - -make communication and learning a more fluid, seamless process.
 - -allow students and teachers to access resources and materials online, all the time.
 - -engage students in online tasks and discussions.
 - -give students immediate feedback on assignments and assessments.
 - -integrate with PowerSchool.

eLearning and Learning Management System (LMS)

- •The onboarding process for our district began the week of July 6 and is ongoing.
- •We anticipate training for instructional personnel to begin the week of July 27.
- •A train-the-trainer format will be used.
- •Each school's TTL and principal will be trained first, and then tasked with training the rest of the staff

Newberry ONE Institute for eLearning

- •Offered to all students, PK-12, for the duration of the 2020-21 school year
- •Completely virtual program using Schoology with live lessons, projects, assessments, and assignments, with dedicated virtual-only teachers for grades K-12 (3- and 4-year-old children will receive materials from their teachers and other school staff in addition to a district device for instructional apps)
- •All core courses will be included in this program, but there is no guarantee that every elective available at the home schools will be provided
- •Students can reapply for admission back to their home school every 9 weeks; students will be considered for return on a **space-available basis**

Newberry ONE Institute for eLearning

- •Students can also apply for admission to the virtual program every 9 weeks and will be considered on a **space-available basis**
- •Parents must confirm that they have reliable Internet access at their home
- •After the application deadline has passed, students will be rostered and teachers will be allocated using the same pupil-teacher ratios we use for in-person teaching
- Teachers who would like to teach in this program can apply (strong instructional technology skills will be required)
- •We'd like to notify students/parents of this option and provide access to the application as soon as possible

Governor's Announcement - July 15

Recommended start date of September 8 for all students

Parents need to have a choice whether they want their children to go in class 5 days a week or virtual education at home (no hybrid schedule).

All children must have the opportunity to attend in class instruction and it is up to parents to make that choice.

Plan for reopening due to the South Carolina Department of Education for approval by July 17, 2020.
