To provide our students educational options that meet personal health safety needs, Heavener High School is offering online options for your child’s course work for the 2020-21 school year.

**If you wish for your child to attend traditional, face-to-face high school classes on the Heavener High School Campus, you do NOT need to submit this form.**

**IMPORTANT:** The online option you choose will apply for the entire school year, 2020-2021; however, you may submit a revision of this request form by the last day of the Fall 2020 semester to specify options for Spring 2021.

**Students have until the end of the school day on Tuesday, August 25, 2020 to submit this form with required signatures and dates to the high school office.**

Any students who has not submitted a form by the end of the day on August 12 will be enrolled in traditional course work and will be required to attend classes as scheduled on the Heavener High School campus.

KTC students who wish to have blended or virtual course work must attend scheduled KTC campus courses in their assigned morning or afternoon program, and then work with school personnel to schedule the balance of Heavener High School classes.
