


Mr. Clark made the motion to approve the following resolution:

WHEREAS, on March 9, 2020, Governor DeWine declared a State of Emergency in Executive Order 2020-01D; and

WHEREAS, on March 11, 2020, the head of the World Health Organization declared COVID-19 a pandemic; and

WHEREAS, on March 22, The Director of Public Health issued a “Stay at Home” Order; and

WHEREAS, Governor Mike DeWine closed all Ohio schools from March 16, 2020, until at least May 1, 2020; and

WHEREAS, as a result of these events, and the transition to distance learning, the Superintendent and Treasurer have been required, and may be required in the near term, to take swift action in response to the pandemic, in order to continue providing instruction and nutrition to students; and

WHEREAS, the Board has adopted Policy 6320 which authorizes approval of certain contracts and purchases using specific procedures and within certain limits.

BE IT THEREFORE RESOLVED that the Coshocton City School District Board of Education declares an emergency; and

BE IT FURTHER RESOLVED that the actions of the Superintendent and Treasurer, and their designees, with respect to the continuation of instruction and nutrition, to date, are ratified as follows:

The Coshocton City Schools District Board of Education hereby authorizes the Superintendent and Treasurer, during the time period that Coshocton City School District's school buildings are closed to students due to COVID-19 or May 29, 2020, whichever is earlier, to take any and all actions necessary to maintain educational programming for students and provide for the safety of all students and staff, which includes, directing students and staff as appropriate; implementing curriculum as appropriate; purchasing, obtaining, leasing or otherwise utilizing and paying for all necessary supplies, services, technology and equipment necessary for education through alternative means within current budget appropriations; and complying with orders and guidance issued by the federal and state government and agencies in response to the COVID-19 crisis.

BE IT FURTHER RESOLVED that the Superintendent and Treasurer, and their designees, are authorized to take emergency measures, make decisions using their best judgement in these unique circumstances, and to expend funds that may exceed policy 6320 limitations for products and services needed to respond to this emergency. Such purchases shall be presented to the Board to be ratified at the next regular meeting.

WHEREAS, Governor Mike DeWine has declared a state of emergency in Ohio, and the Governor and the Director of the Ohio Department of Health have closed all Ohio schools to students from March 15, 2020, until at least May 1, 2020; and

WHEREAS, Governor DeWine and the Ohio Department of Education have stated that schools should work to provide education through alternative means during the period of extended school closure; and

WHEREAS, Section 15 of Ohio House Bill 197, signed into law by Governor DeWine on March 27, 2020, permits a board of education to adopt a plan for distance learning for students during the school shutdown, even if it had not adopted on previously pursuant to Revised Code § 3313.482; and

WHEREAS, Ohio Department of Education guidance indicates that schools may use “blizzard bags” during this extended school closure, beyond the normal three days;

Thursday, April 16, 2020

NOW, THEREFORE, BE IT RESOLVED that pursuant to Ohio House Bill 197, Section 15, the Board hereby approves the provision of distance learning retroactive to March 16, 2020, and continuing through the period of extended school closure due to COVID-19.

BE IT FURTHER RESOLVED that the Board ratifies and authorizes the Superintendent's development and implementation of a plan of distance learning, as set forth in **Exhibit A**, to enable and require students of the district to access and complete classroom lessons in order to make up hours because of the closing of schools in compliance with orders of the Governor, Director of the Ohio Department of Health, a local board of health, and/or an extension of such an order due to the COVID-19 pandemic.

Remote Learning Plan

Amendment to the Adopted Calamity Day Alternative Make-Up Plan

Due to the School Closure that has been mandated beginning in March as a result of the Coronavirus in Ohio, Coshocton City Schools has had to change the delivery of its instruction to include Remote Learning.

According to the Ohio Department of Education, "...remote learning means each student is experiencing a learning opportunity supported by a teacher or educator who is in a different location. Working in partnership with educational delivery partners, an educator might deliver instruction by using a device and checking in with students regularly. Remote learning also can include video or audio instruction delivered online or via television, video, telephone or another method that relies on computer or communications technology. It also may include use of printed, paper-based materials that incorporate assignments that engage and seek feedback from students."

Initial School Closure

To meet the needs of the initial school closure, effective March 16, 2020, teachers may provide up to a total of six "blizzard bags" or online learning assignments for students instead of the three that are typically provided in a regular school year. In addition, the expectation of returning the work within two weeks will be extended allowing these paper lessons to be returned by the end of the school year or when students are allowed to come back to the school according to the Governor's orders, whichever comes first. This will allow for all parties to safely abide by the current Stay At Home orders set out by the Governor. However, we may provide opportunities for student work to be returned when safe means are determined for buildings.

Continued School Closure

For the remainder of the ordered school closure the Coshocton City Schools will follow the state's recommendations on remote learning opportunities for our students.

The District will:

- Provide Chromebooks and mifis to students who do not have a device or access to internet at home
- Provide school email accounts to all students in grades K-12 who didn't already have them to assure a means for communication

- Provide remote access to textbooks and other resources as needed for instruction
- Provide paper copies of the remote learning activities to students as needed
- Provide ongoing intervention support and related services as identified in students' individualized service plans

Teachers are expected to:

- Use Google Classroom to post lessons and information to support the learning opportunities
- Regularly assess student progress and adjust lessons accordingly
- Be available from 9:00am to 2:00pm every day to support student learning via appropriate methods. This may include, but is not limited to emails, synchronous lessons, scheduled Zoom meetings, or scheduled phone calls.
- Reach out to their students every day via Google Classroom
- Make contact with each of their students *at least* one to two times during a school week.
- If a teacher is unable to make contact with students or is not getting classwork from students for more than 3 days, it is to be promptly reported to administrators
- Maintain any needed accommodations for students who have specific learning needs

Students are expected to:

- Make a diligent effort to engage in and complete assignments provided by their teachers
- Students have until the end of the year or two weeks after returning to school to submit assignments
- Engage in no more than 3 hours of instruction/activities per week per subject area
- Maintain regular contact with the teachers (in the younger grades, this needs to be via the parents/guardians)

Administrators are expected to:

- Maintain and monitor teacher lessons to maintain that appropriate lessons are being provided for students
- Maintain and monitor documentation of student engagement and make attempts of contact those students reported as not engaged (this may be supported by our School Resource Officer)
- Work with parents to help support their students as needed
- Provide support to teachers and professional support opportunities to continue developing remote learning capabilities

This plan includes the written consent of the teachers' employee representative as designated under division (B) of section 4117.04. Such consent is on file in the official file of the board of education and is hereby incorporated into this plan as if specifically rewritten.

Should circumstances warrant a change in the plan during the 2019-2020 school year, this contingency plan may be amended by the Superintendent, along with CCEA representation, at any time in his or her discretion.
