Board Meeting Elementary Report May 11, 2020

- 1. Remote learning is continuing with some teachers and students finding it to be successful, while others are challenged by it.
 - -Some students are going above and beyond what is expected, while others struggle with the internet, schedule, motivation, and responsibility.
 - -Teachers continue to send learning packets as well as online assignments.
 - -All elementary teachers are having Google Meetings with their students one-to-one, small group and whole group.
- 2. This week the elementary staff is working on the following:
 - -Class list
 - -End of year report cards What do they look like with remote learning for elementary students?
 - -End of year activities Remote Field Day, End of Year Parade, Materials & Device Collection
- 3. Two elementary teachers are signed up to take Responsive Classroom remotely in June.

- Attending daily Zoom meetings with the School Finance Team from the DOE and other Business Mangers around the State. The meetings are primarily question and answer sessions and are proving to be a great resource. Topics include:
 - The application process for CARES funding and allowable costs
 - Budget process during COVID
 - Food service, cleaning, summer school, transportation
 - Concerns about future curtailments from the State

CARES Funding

- State's estimate is 91% of 80% of our Title I Funding
- Application is pending answers from the US Department of Education some
 of the allocation may be shared with private schools. If so, there will be less
 for public schools.
- Recommendation is that this money be spent on one-time expenses that can be directly tied to COVID
 - Any expenditures charged to CARES will not be considered as reimbursable for future subsidy calculations— schools must be mindful of this when completing the application

• FEMA Public Assistance Grants

- FEMA is also offering assistance for schools and municipalities to help respond to unanticipated COVID expenses
- Attended a webinar on it last week and submitted a request for assistance
- o If we are approved, we will be given the opportunity to apply for funding
 - The application process is complex and the regulations extensive, but schools are encouraged to apply
 - FEMA funds are not related to CARES

Possible curtailment in FY 21

- The State has promised that it is able to meet its obligations for school funding through FY 20, but currently no promise for FY 21
- There is a lot of concern due to revenue loss at the State level that we could experience a curtailment in FY 21
 - The State will not be doing revenue forecasting until August, which is too late for the school budget process
 - Many business managers are planning to increase their undesignated fund balance with any budget savings this year
 - Undesignated fund balance can be used as a Rainy Day or budget stabilization fund. It is also a help with cash flow when the State or towns are slow to pay.
- By law, schools are not allowed more than 3% of the prior year's budget in undesignated fund balance. However, the State has been lenient with districts

- recognizing that this percentage is less than ideal. Most auditors recommend between 12-18%.
- As of April 30, we are forecasting a budget savings of approximately \$35,000. Doug Burdin from Maine School Management has also said that they still plan to pay unemployment returns. RSU 50 is slated to receive \$30,000 in unanticipated revenue from our unemployment trust fund.
- School Revolving Renovations Fund Grant/Loan to replace the elementary lift
 - The Board previously voted on the application and will need to vote to accept the funds tonight
 - Our share is considered a pre-paid loan \$13,500/State share is a grant \$22,200
 - Lift is on order with Maine Accessibility and Mike Nadeau & Sons has started the construction
- The Siemens presentation originally scheduled for tonight has been postponed. They have emailed us their reports, which we will forward to the Board. Our guaranteed cost savings from heat and electricity for year 1 was \$80,308. Our actual cost savings for the first year was \$83,403, which exceeded the guarantee by \$3,095. According to the report, we also saved \$31,159 during the construction period for a total measured cost savings through 2/29/20 of \$114,561.
