#### EARLY ACTIONS

- SAFETY AND SECURITY HAS ALWAYS BEEN FOCUS, USUALLY FOCUSING ON ILLEGAL DRUG USE OR FIRE SAFETY, ETC. A NEW FOCUS ON SCHOOL OPERATIONS SINCE 1999'S COLUMBINE
- SCHOOLS ALL OVER THE WORLD BEGAN TO RAMP UP PROCEDURAL PRACTICE AND DEDICATION OF PERSONNEL THROUGH A VARIETY OF ACTIONS: CREATION OF POLICE DEPARTMENTS; PARTNERSHIPS WITH LOCAL LAW ENFORCEMENT AGENCIES; OR POLICY FOR STAFF TO SERVE AS A SECURITY FORCE OR RESPONSE TEAM

#### TYLER ISD EARLY ACTIONS

- Texas Government Code 551.076
- TYLER ISD, AS ALLOWED BY TEXAS LAW, PER ITS ID AS A
  TAXING ENTITY, CREATED ITS OWN POLICE FORCE IN 2003.
  IT NOW CARRIES AN AVERAGE OF AROUND 20 OR SO
  OFFICERS PER YEAR, ALONG WITH A K-9 UNIT
- MID 2000'S TYLER COMMUNITY MADE A COMMITMENT TO FACILITY UPDATES EITHER THROUGH RENOVATION OR NEW CONSTRUCTION, OR A COMBINATION OF BOTH (MOST RECENT MAY 2017 BOND FOR BOTH HIGH SCHOOLS)

### ROUTINE ACTIONS

- DRILLS AT ALL CAMPUSES EXIST, WITH REPORTING OF SOME REQUIRED BY LAW
- SAFETY AUDITS CONDUCTED ON THREE YEAR CYCLES BETWEEN ALL CAMPUSES (POLICE + ADMIN)
- Safety audits are submitted to the Texas
   School Safety Center Most Recent April 2018 Compliant

## ROUTINE ACTIONS (CONT.)

- Constant communication between campus administration; Central Administration; and Tyler ISD police department (What is Public vs What is Not)
- COMMUNICATION/COORDINATION WITH CITY & COUNTY LAW ENFORCEMENT, ALONG WITH JUVENILE AND ADULT JUDICIAL AND MENTAL HEALTH OFFICIALS AND SERVICES
- FIDELITY TO STUDENT CODE OF CONDUCT AND COUNSELING SERVICES; COMMITMENT TO ACCOUNTABILITY WHILE WORKING TOWARD RESTORATIONS
- SAFE SCHOOLS PD FOR ALL STAFF ANUALLY

- ALL-SCHOOLS SOCIAL-EMOTIONAL PROGRAM
- DEPLOY ATTAINABLE RECOMMENDATIONS FROM ACTION TEAMS
- SEEK CUTTING EDGE DETERRENTS FOR INSTALLATION IN CURRENT AND FUTURE FACILITIES

## FUTURE ACTIONS (CONT.)

- SEE IT-SAY IT APP SELECTION
- ELEMENTARY SCHOOL PARTNERSHIPS WITH TYLER ISD AND SMITH COUNTY SHERIFF DEPARTMENT
- Consider the creation of director level position solely responsible for security of the school system
- SYSTEM WIDE CONTINUING AND PREPARATION EDUCATION FOR STUDENTS AND STAFF
- CE FOR POLICE DEPARTMENT OUTSIDE OF MINIMUM RECERTIFICATION REQUIREMENTS
