Summary and Background Information

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund.

The federal ARP statute requires that States reserve ARP ESSER funds for three State-level reservations for evidence-based activities and interventions that respond to students' social, emotional, mental health, and academic needs and address the disproportionate impact of COVID-19 on students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children and youth in foster care, and migratory students.

- Not less than 5 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, activities to address the
 academic impact of lost instructional time by supporting the implementation of evidence-based interventions.
- Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based summer enrichment programs.
- Not less than 1 percent of the State's grant must be reserved to carry out, directly or through subgrants or contracts, the implementation of evidence-based comprehensive after-school programs.

The 2021-2022 enacted New York State budget fully allocated the required SEA reserves as subgrants to 398 LEAs and NYSED has made allocations to two additional LEAs. Specific LEA allocations are detailed in Columns D, E, and F in the **ARP ESSER Allocations Chart** (see also in the Document Library). Please note that these funds are in addition to the *90% LEA ARP-ESSER ALLOCATION* listed in Column C of that workbook and must be budgeted for separately.

As indicated in NYSED's approved **ARP ESSER State Plan**, NYSED has included within this application a list of evidence-based interventions related to each state reserve. Students in these studies have not been randomly assigned, but researchers have used statistical matching methods that allow them to speak with confidence that the strategy results in an improved outcome. These studies meet the What Works Clearinghouse evidence

standards with reservations. The studies use large, multi-site samples. No other studies show that this strategy negatively impacts an outcome.

- Tier 3 Promising Evidence: Supported by at least one well designed, well implemented correlational study with statistical controls for selection bias. There is evidence that this strategy improves a student outcome (reading scores, attendance rates), but that research may consist of correlational studies -- studies that can show a relationship between the strategy and outcome but cannot show that the improved outcome was the result of the strategy. The studies supporting Tier 3 strategies do not have to be based on large, multi-site samples. A strategy that would otherwise be considered Tier 1 or Tier 2, but it does not meet the sample size requirements, is considered Tier 3. No other studies show that this strategy negatively impacts an outcome.
- Tier 4 Demonstrates a Rationale: High-quality research findings or positive evaluation suggests that this will likely improve student outcomes or other relevant outcomes; and there are ongoing efforts to examine the effects of such activity, strategy, or intervention. Based on existing research, the intervention cannot yet be defined as a Tier 1, Tier 2 or Tier 3. However, there is good reason to believe based on existing research and data that the intervention could improve relevant student outcomes.

The District solicited feedback from all students, parents, employees, BOE and community members in the form of a survey designed to identify the areas of greatest need and concern as a result of COVID-19. All stakeholders were provided the opportunity to submit additional comments and suggestions to the District via the Business Official's email. The plan was thoughtfully prepared and required additional input as new members of the Administration team joined the District in August (Superintendent) and September (Principal).

 - In addition to the annual meetings for our classified students, we are now also holding annual meetings for all of our 504 students. The parents of students who are referred to our IST, as well as those who are identified through a combination of our universal screeners, and reviews of our attendance, discipline, and grade records will be scheduled for biweekly conferences with our school counseling staff. These meetings will be used to share regular updates about the student's progress and dispositions, and to receive feedback from parents regarding the student's home life and social-emotional wellbeing.

As a component of our comprehensive model of school counseling, our clinical staff will be conducting small group (4-8 students) counseling. On a quarterly basis, counselors will teach lessons, make presentations, and lead in class activities centered around SEL. These activities will include opportunities to collect documented feeback from the students. Additionally, surveys from XSEL Labs were administered at the beginning of the year to each student in order to further identify their unique social-emotional needs. This evidence, coupled with the notes gathered through the small group counseling sessions will be reviewed by the leadership team for use in program-planning.

Data from teacher reports, report card grades, and scores from our quarterly benchmark testing through IXL will be used to determine the academic needs of students. As a high-needs district, a large number of our students are from low-income families. The data collected from this at-risk population will be brought to our IST/MTSS team to plan additional, individualized interventions as needed.

In structuring and adjusting our AIS program, we selected the 3-tiered RTI system, which is supported by strong (Tier 1) evidence, as our foundation. Within that structure, we utilized Jim Wright's Intervention Central to develop our programming as his work is widely considered to represent best-practice in our field and whose impact on student performance has been thoroughly researched.

Our SEL plan is centered around the Comprehensive Model for School Counseling, as adopted by NYS regulations. The specific sessions and lessons which our clinicians will be implementing are based upon ASCA's Mindsets and Behaviors. These are based on research conducted by the University of Chicago Consortium on Chicago School Research.

While direct academic support is a component of our afterschool programming, the primary goal of these activities is more social-emotional in its focus. After 2 years of disjointed remote, hybrid, and socially distanced instruction, students have demonstrated social anxiety and the need for structured opportunities to interact socially with their peers. We aim to provide a forum in which students can socially and constructively engage with their peers in a more relaxed environment. Specifically, we will be histing the following activities: Band Club; Chorus; Class Advisories - 7th, 8th, 9th, 10th, 11th, and 12th grades; Color Guard; Drama Club; Fine Arts Club; Multimedia Club, National Honor Society; SADD; School Store; School Play Production; Student Council; Yearbook.

The variety of options is also designed to offer students an outlet to explore interests and pursue their passions. As these outcomes are more readily accessed through indirect measurements, the administration and clinical staff will rely upon student attendance (both in the activities and in class) and discipline records to assess their efficacy. An eligibility list will be generated biweekly to ensure that students who are participating in these activities are also participating in school. Parents of students who are identified on the list will receive a copy of their child's full progress report for that 2 week period.

Summer learning programs can offer another opportunity to accelerate learning, especially for those students most impacted by disruptions to learning during the school year. Our SCUBA program is being modelled after an established and highly regarded program in a nearby district (Cuba-Rushford). The gardening program is an extension of our popular Environmental Technology class, which runs in the high school.
