

Nye County School District Distance Learning Contract

Nye County School District is offering Distance Learning to students during the COVID-19 pandemic. Distance Learning provides an opportunity for PK-12 students to attend classes online and is more comparable to the classroom-learning environment. Students have remote access to teachers and can receive all assistance needed off-site using standard communication tools. At the elementary level (PK-5), there will be at least one online teacher per grade level and at the secondary level (6-12) there will be at least one online teacher per course.

Approval to participate in Distance Learning is determined by the student's school. Students will need to actively participate and complete assignments and assessments in all scheduled courses in order to continue in Distance Learning. Students will lose this privilege if they do not meet the requirements of each course. A conference may be scheduled to determine if they may continue Distance Learning or return to on-site classes.
