

MINUTES OF A SPECIAL MEETING OF THE WILLIAMS UNIFIED SCHOOL DISTRICT NO. 2 GOVERNING BOARD WEDNESDAY, JULY 22, 2020

- Mrs. Dent called the meeting the order at 6:00PM and led the Pledge of Allegiance.
- Motion made by Mrs. Wells to adopt the agenda, second by Mrs. Payne.
- Motion approved 5/0.

DISCUSSION

School reopening –general discussion

- Mr. Honsinger explained we are awaiting word from the Governor, he is scheduled to hold a briefing tomorrow Thursday, July 23 at 3PM.
- We are currently set to start school on August 10th with remote learning and August 17th in brick and mortar. Registration is currently in progress at both schools.
- Mr. Evans surveyed parents of WHS and received 89 responses, 18 said they will register for distant learning, 1 said they will not return to the district and the remaining 70 want to return to campus.
- Mrs. Morrison also surveyed WEMS student families, 212 responded to the survey, 57 will register for distant learning, 149 wanting to return to campus and 6 will not return to the district.
- Mr. Nixon said it was hard to believe, I come in contact with many parents daily and they all say get them back to school, keep them clean but get them back.
- Mr. Nixon said as the Police Chief he is informed of every positive COVID case in our zip code, there have not been more than 7 active cases at one time.
- Mr. Honsinger mentioned the Coconino County website statistics show a much higher number.
- Mrs. Wells said the public and parents look to the County for the number of cases.
- Mr. Fleishman mention two weeks ago there were 9 cases and tonight 42 cases. Our responsibility is to do the upmost of protection for our student's safety. The Trust and ASBA have medical guidelines to plan a safe opening. I would like our plan to be reviewed by our attorney, we owe it to our students and staff.
- Mrs. Wells said we have to do what is right for our staff, students and community. We need to move forward and see what the Governor says tomorrow.
- Mrs. Dent said we can discuss this for hours but we need to wait until the Governor speaks. We need
 to make the best decision for students, staff and community. We know our current plan is a living
 document and we must use good judgement with our planning.
- Mr. Honsinger said we will need to schedule a special meeting before school starts and after the Governors briefing for Wednesday, August 5th.
- Mr. Nixon asked how will staff training be set up this year and how many classes do we have that can't be taught online? Mr. Honsinger responded, staff training will be online for teachers and staff and we want to say we have zero classes that can't be taught on line. Our professional development will be time to brain storm, all classes have a certain amount of book work that must be completed, this will not be as good as in person but we will get creative in our methods of teaching online.
- Mr. Honsinger said we currently have two staff members who will not be coming back and two that have asked for accommodations.
- Mrs. Wells asked hypothetically, if we are told we must teach remote for the 1st quarter what happens to the Athletic programs? Mr. Evans said AIA will follow up after the Governors address with a plan.

- Mrs. Dent acknowledged a request to speak from parent Susan Daly. Mrs. Daly thanked the Board for their hard work and the hard decisions they must make. I have a student who will not do well online, and I'm concerned with how do we do remote as parent when both parents work? There are lots of decision to make but we must move on.
- Mr. Honsinger said we are not going to do any more than the Governor ask us to do. Know you are being heard, we understand, we have employees who work and also have young students.

 - Mr. Fleishman questioned item 8, Academically ineligible athletics will travel with team? Mr. Evans said the Committee said no, the athlete should not travel but the AD and coaches thought it is more of a consequence to travel and not play.
 - Mrs. Dent asked why did the coaches not join the committee in the meetings? Example, # 3 Admission of guilt, the coaches want to see "may be taken into account", this is why we asked for a committee to review the Code of Conduct, we cannot be flexible.
 - Mrs. Payne agreed, I was at every meeting and I was disappointed we did not all meet as a committee. The committee wants #3 to read Student know rules and consequences along with expectation ahead of time, does not reduce consequences.
 - Mr. Nixon said #6, Coaches and AD would like to see police report added as further definition of burden of proof, we cannot always provide police report, this cannot be included.
 - Mr. Nixon revised his motion to follow what committee recommend and not what the coaches and AD suggest on item 3,6 and 8, second by Mrs. Wells.
 - Motion approved 5/0.
