### Approval of May 14, 2020 Regular School Board Meeting Minutes

### Action Item #1 - Consider Changes to the Riverview School District Board Policy 7.5 to Reflect Arkansas Code

Mrs. Ballard recommended to the board to approve the changing of board policy 7.5 in regards to bidding to reflect the Arkansas purchasing threshold for bidding for the 2020-2021 school year. The new ADE state bidding will be \$21,284.00 for the 2020-2021 school year. Riverview School District Board Policy 7.5 is currently set as \$20,000.00. At 7:08 pm, motion was made by Keith Baker to approve to change the Riverview School District Board Policy 7.5 to \$21,284.00 for threshold for bidding from \$20,000.00. Second by Darren Gordon. ### Action Item #2 – Consider Passing a Resolution for the Suspension of District Policy to Align with Emergency COVID-19 Legislation and Statutory/Rule Waivers.

Once Arkansas is declared out of a state of emergency, all district board policies will be back in force as originally. ### Action Item #3 - Consider Purchase of Land Next to Riverview Judsonia Gym

Mrs. Ballard presented to the board a request from Norman Enloe to the Riverview School District to purchase land located at 810 ½ Jackson Street in Judsonia, Arkansas, for the purchase price of \$8,000.00. The land is located by the Judsonia Gym and it does have a house on the land. After much discussion, the board wished to table Action Item #3 at this time.
