



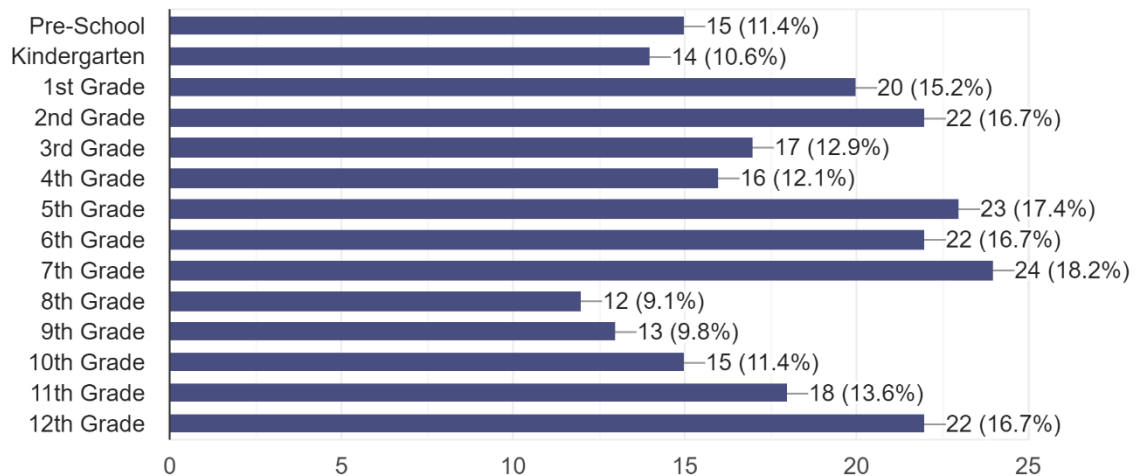
## Superior Central Return to School – Parent Survey Results

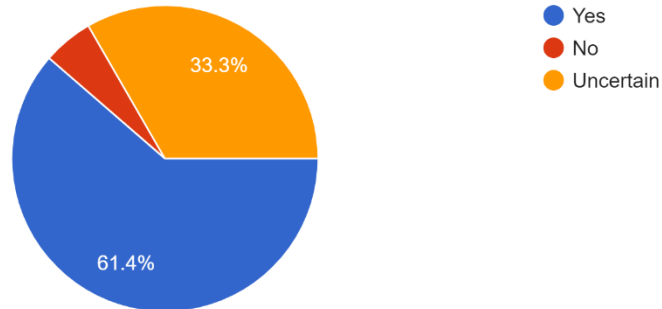

  - **My child will be attending SC for in-person instruction 50% (66)**

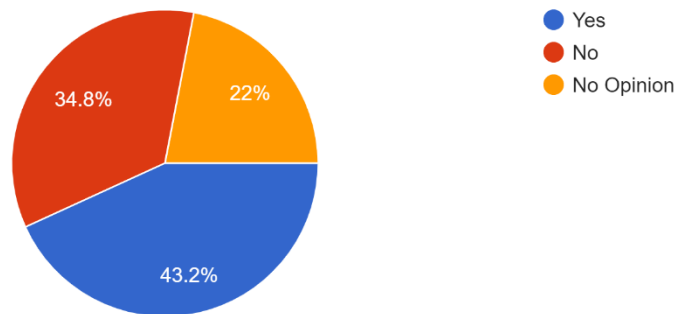

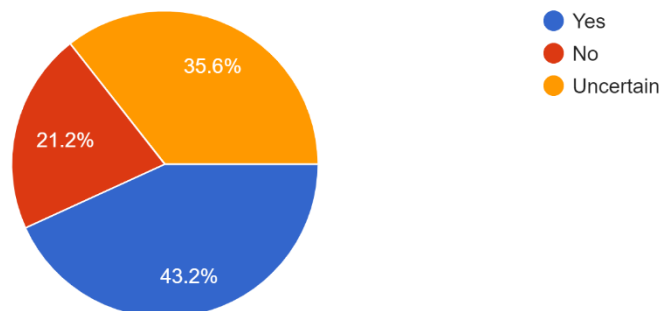
If you are planning to send your child(ren) to school in the fall, do you feel staff should be required to wear face masks?

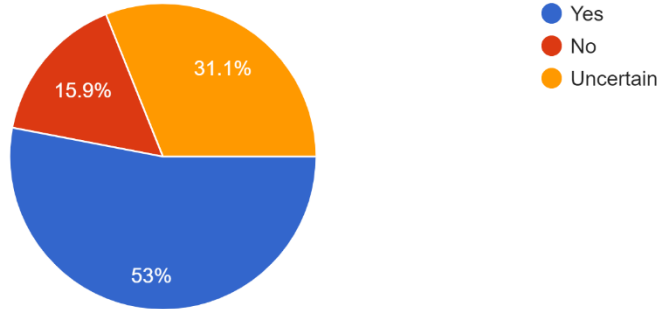
If wearing a face mask all day is a condition of your child(ren) attending school, will you send your child(ren)?

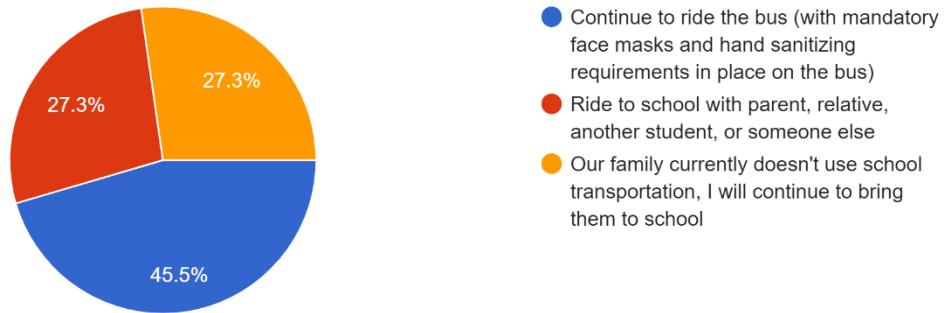
