SUPERINTENDENT REPORT

Dr. Ritchey reported on the following items:

- Various plans have been developed by schools for resuming classes in the fall. The final version of Re-set & Re-start Ohio have not yet been released. It is scheduled to be released June 30, 2020. The Milton-Union administrative team has developed three options:
 - o Regular start with extra precautions
 - Two hybrid models
 - o Remote options working with the Miami Co. ESC

Mrs. Stasiak asked if parents had been surveyed. Dr. Ritchey responded that a survey was placed on social media sites. Approximately 20-25% of respondents prefer online education, which is a typical percentage for schools the size of Milton-Union.

Mr. Thompson asked about ODE's preference. Dr. Ritchey stated sports and opening school are going in two different directions. A normal start is preferable but safety is a concern. Environmental modifications may be needed. Once the Restart guide is released, a plan should be in place by mid-July.

- HB 164 was signed by Gov. DeWine last week. There are several items contained in the bill. It provides relief for teacher evaluations during the transition to the new teacher evaluation system.
- HB 164 also provides a one-year moratorium on the third-grade reading guarantee.
- In-person graduation is set for June 26th. Practice will be held on Thursday morning. Six-foot social distancing will be observed. There will be no hand-shaking.
- Tickets will be passed out to students at practice.
- A parade will follow the graduation ceremony.

Mrs. Brumbaugh thanked everyone for making this happen for the students.

WHEREAS, the Milton-Union Schools Board of Education desires that students have learning opportunities even when schools are closed for any of the reasons specified in section 3313.482 of the Ohio Revised Code; and

WHEREAS, section 3313.482 authorizes a board of education to adopt a resolution by August 1 of each year to provide on-line learning opportunities for students in lieu of attendance on such days of closure;

NOW THEREFORE BE IT, AND IT IS, HEREBY RESOLVED that the Milton-Union Schools Board of Education hereby approves the following plan.

PLAN FOR ALTERNATIVE MAKE-UP OF CALAMITY DAYS

Pursuant to Ohio Revised Code section 3313.482, the Board of Education of Milton-Union Schools hereby authorizes the following plan to allow students of the district to access and complete classroom lessons in order to fulfill up to a maximum of the number of hours that are the equivalent of three school days because of the closing of schools for any of the reasons specified in section 3313.482.

- 1) This plan is adopted, pursuant to approval of the Board of Education, prior to August 1.
- 2) This plan includes the written consent of the teachers' employee representative as designated under division (B) of section 4117.04. Such consent is on file in the official file of the board of education and is hereby incorporated into this plan as if specifically rewritten.
- 3) Not later than November 1 of the 2020-2021 school year, each classroom teacher shall develop a sufficient number of lessons for each course taught by that teacher with such lessons requiring, in the judgment of the teacher, an amount of time equal to or greater than the number of hours that are the equivalent of three school days in such teacher's class.
- 4) The teacher shall designate the order in which the lessons are to be posted on the district's web portal or website.
- 5) Teachers will update or replace such lessons as necessary throughout the school year based on the instructional progress of students.
- 6) As soon as practicable after an announced school closure authorized under section 3313.482, the appropriate administrator may direct staff to make the designated lessons available on the district's portal or site. Each lesson shall be posted for each course that was scheduled to meet on the day of the school closing.
- 7) Each student enrolled in a course for which a lesson is posted shall be granted a two-week period from the date of posting to complete the lesson. If the student does not complete the lesson within this time period, the student will receive an incomplete or failing grade unless a reason sufficient to the teacher is provided.
- 8) Students without access to a computer shall be permitted to complete the posted lessons at school after the reopening of school. Students utilizing this option will be granted two weeks from the date of reopening to complete such lessons. If the student does not complete the lesson within this time period, the student will receive an incomplete or failing grade unless a reason sufficient to the teacher is provided. The district will provide access to district computers before, during, or after the school day (provided that the equipment is available and accessible at those times) or may provide a substantially similar paper lesson in order for students to complete the assignments.

RESOLUTION DETERMINING TO PROCEED TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

WHEREAS, a majority of electors of the Milton-Union Exempted Village School District, County of Miami, Ohio (the "School District"), approved a tax levy for permanent improvements at a rate not exceeding three and nine-tenths (3.9) mills for each one dollar of valuation for a period of five (5) years at an election held on November 3, 2015; and

WHEREAS, pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, this board has determined the necessity to levy a renewal tax in excess of such ten-mill limitation for the purpose of permanent improvements at a rate not exceeding three and nine-tenths (3.9) mills for each one dollar (\$1.00) of valuation for a period of five (5) years.

BE IT RESOLVED by the Board of Education of the School District, two-thirds of all the members elected thereto concurring:

SECTION 1. That the board of education hereby determines to proceed with the levy and the question of the adoption of said tax shall be submitted to the electors of the entire territory of the School District at the election to be held on November 3, 2020, and if said tax is approved by a majority of said electors such tax levy shall first be placed upon the 2021 tax list and duplicate, for first collection in calendar year 2022.

SECTION 2. That the form of the ballot to be used at said election shall be substantially as follows:

A majority affirmative vote is necessary for passage

A renewal of a tax for the benefit of the Milton-Union Exempted Village School District **FOR THE PURPOSE OF PERMANENT IMPROVEMENTS**, at a rate not exceeding three and nine-tenths (3.9) mills for each one dollar (\$1.00) of valuation, which amounts to thirty-nine cents (\$0.39) for each one hundred dollars (\$100.00) of valuation, for five (5) years, commencing in 2021, first due in calendar year 2022.
