

The District Offers O.O% Tax Increase, With No Elimination of Programs or Classes

The Board of Education and central administration of the Lawrence Union Free School District take pride in our ability to maintain the highest standard of excellence in education at the lowest possible tax impact. That's why we have worked so tirelessly to once again propose a school district budget that features a **O.O% tax levy increase** while maintaining all programs and services offered to both the public and non-public school families.

Our philosophy in crafting a budget is simple. We have two primary objectives: we care for our students, and we care for the taxpayers. Every decision we make stems from how we can best support these constituencies. We care for students by supporting and sustaining award-winning programs, initiatives, technology upgrades, teachers, facilities and more. And we care for taxpayers by doing so without increasing our tax levy. We are able to accomplish this is testament to the hard work of our Lawrence team and the unwavering support of our parents and community. Lawrence Public School is truly a collaborative effort.

#### ■ SEAMLESS CONTINUATION OF TECHNOLOGY & DIGITAL LEARNING TOOLS

Lawrence successfully navigated the immediate shift to remote learning in the spring of 2020, and we furthermore prepared ourselves for an increasingly virtual future thanks to the emphasis we place on our tech initiatives. We are constantly updating our technology and set and meet long and short-term goals. The proposed 2022-2023 budget continues to keep us ready for the challenges of the future.

#### ■ CAPITAL IMPROVEMENTS WITH NO TAX INCREASE

#### **VOTER ELIGIBILITY**

All voters must be United States citizens, 18 years old or older, and a resident of School District 15 for at least thirty days prior to the vote. In addition, a resident must be registered either with the school district or with the Nassau County Board of Elections. If you have voted in either a school district election within the past year or a local general election anytime in the past four years, you are already registered. If you are not already registered with either, you may register with the County online or with the DMV online or download their form and mail it in. The form can also be picked up at your local Post Office.

#### **ABSENTEE BALLOT APPLICATIONS**

Applications for absentee ballots may be obtained at the Office of the District Clerk and are also available on the district website at www.lawrence.org. Completed applications must be received in the District Clerk's office by May 10, 2022 if the ballot is to be mailed to the voter. If the ballot is to be hand delivered to the voter, the application must be received in the District Clerk's office by Monday, May 10, 2022. All completed absentee ballots must be received in the District Clerk's office by 5:00 p.m. on the day of the election, May 17, 2022.

#### **VOTER REGISTRATION**

You may register in person throughout the school year with Ms. Mohinder Bharaj, District Clerk. By doing so, you will be qualified only to vote in school district elections. ## WHAT IS ON THE BALLOT?

#### **PROPOSITION NO. 1 - SCHOOL BUDGET**

**RESOLVED**, that the Board of Education of the Lawrence Union Free School District No. 15, Town of Hempstead, Nassau County, New York, be authorized to expend the sum of **One Hundred Two Million Four Hundred Ninety Thousand Fifty Three Dollars (\$102,490,053.00)** for the fiscal year 2022–2023, and is further authorized to levy the necessary tax for the above purpose upon the taxable property of the School District, after first deducting the monies available from State Aid and other sources.

#### **PROPOSITION NO. 2 - LIBRARY BUDGET**

**RESOLVED**, that the sum of **Three Million One Hundred Seventy Two Thousand Dollars (\$3,172,000.00)** be appropriated for the Peninsula Public Library for the fiscal year 2022-2023 and that said amount be raised by tax upon the taxable property of the Lawrence Union Free School District No. 15, Town of Hempstead, Nassau County, New York, pursuant to §259 of the Education Law, and be levied and collected in the same manner as are other general taxes, after first deducting the monies available from State Aid and other sources.

## PROPOSITION NO. 3 - 2022 BUILDING CAPITAL RESERVE FUND CREATION AND EXPENDITURE AUTHORIZATION

**RESOLVED**, that the Board of Education of the Lawrence Union Free School District No. 15 is hereby authorized to establish a Building Capital Reserve Fund pursuant to §3651 of the Education Law (to be known as the "2022 Building Capital Reserve Fund") and expend funds from such Reserve for the purpose of financing reconstruction, renovation and equipping of: 1) Lawrence High School, including Classroom Renovations, Athletic Wing Renovations, Library Renovations, Air Conditioning Installation and HVAC Improvements, Site Improvements;

2) Lawrence Middle School, including Classroom Renovations, Cafeteria Renovations, Locker Replacements, Library Renovations, Gymnasium Renovations, Air Conditioning Installation and HVAC Improvements, Site Improvements; 3) Lawrence Primary Schools, including Site Improvements; and 4) District wide technology, telephone, safety and security upgrades. The ultimate amount of such Reserve is not to exceed Five Million Dollars (\$5,000,000.00), plus interest and earnings thereon. The probable term of such Reserve is to be ten (10) years, but such Reserve shall continue in existence until liquidated in accordance with the Education Law or until the funds are exhausted. The sources from which the funds shall be obtained for such Reserve are unappropriated fund balances made available by the Board of Education from the 2021-2022 budget.

## PROPOSITION NO. 4 - 2023 BUILDING CAPITAL RESERVE FUND CREATION AND EXPENDITURE AUTHORIZATION

A) RESOLVED, that the Board of Education of the Lawrence Union Free School District No. 15 is hereby authorized to establish a Building Capital Reserve Fund pursuant to §3651 of the Education Law (to be known as the "2023 Building Capital Reserve Fund") and expend funds from such Reserve for the purpose of financing reconstruction, renovation and equipping of: 1) Lawrence High School, including Classroom Renovations, Athletic Wing Renovations, Library Renovations, Air Conditioning Installation and HVAC Improvements, Site Improvements; 2) Lawrence Middle School, including Classroom Renovations, Cafeteria Renovations, Locker Replacements, Library Renovations, Gymnasium Renovations, Air Conditioning Installation and HVAC Improvements, Site Improvements; 3) Lawrence Primary Schools, including Site Improvements; and 4) District wide technology, telephone and security upgrades. The ultimate amount of such Reserve is not to exceed Five Million Dollars (\$5,000,000.00), plus interest and earnings thereon. The probable term of such Reserve is to be ten (10) years, but such Reserve shall continue in existence until liquidated in accordance with the Education Law or until the funds are exhausted. The sources from which the funds shall be obtained for such Reserve are unappropriated fund balances made available by the Board of Education from the 2022-2023 budget. B) RESOLVED, that the Board of Education of the Lawrence Union Free School District No. 15, Town of Hempstead, Nassau County, New York (the "Board"), is hereby authorized to purchase approximately .1164 acres of real property located at 21 Henry Street, Inwood, New York 11096, also known Section 40, Block 075, Lot 2 on the Nassau County Tax Map, together with the buildings and improvements thereon and any appurtenances thereto, and to acquire clear title thereto, for the amount of Eight Hundred Twenty Five Thousand Dollars (\$825,000.00), to be expended from the unappropriated, unassigned fund balance in the general fund as of May 17, 2022, for the purpose of enlarging the Early Childhood Center (School No. 4) grounds and parking area.

#### **SCHOOL BOARD TRUSTEES**

To elect three (3) trustees of the Board of Education for a three (3) year term commencing July 1, 2022, and ending on June 30, 2025.

Incumbents: Michael Hatten, Tova Plaut and David Sussman

#### LIBRARY BOARD TRUSTEE

To elect one (1) trustee of the Peninsula Public Library for a five (5) year term commencing July 1, 2022, and ending on June 30, 2027.

Incumbent: Sarah Yastrab
