WPS Family and Community Engagement Committee meets as part of the school community council twice a year to develop, review, and update the school's Family and Community Engagement Plan. The council approves the plan and any concerns are submitted to the district's Title I Family and Community Engagement Committee. Upon approval of the school plan, it becomes part of the district's plan. A diverse group of parents from K-2 serve on the school and district committees. Additionally, regular meetings are held by the Parents' Advisory Council (PAC) three times per year or as requested by parents.

Meetings will be offered at various times throughout the year. I.e., Kindergarten Parent Orientation is offered at 12:00 noon or 6:00 p.m. Refer to the District Calendar of Events for specific times.

To support the goals of the school improvement plan and the Wynne District Health & Wellness Plan, parent and student activities are offered at school such as fall and spring family nights and online activities. Refer to the district calendar of events for specific dates and times.

Information regarding school activities will be communicated via the building school calendar, daily parent communication folders, group text messages from teachers, Facebook, school website, newspaper, KWYN, marquee, district calendar, and building and district parent newsletters.

Through the COVID-19 health emergency, a lack of internet connectivity for all families has been identified as a barrier for communication with parents and families. The district is studying ways to improve communication with all families.

Wynne Primary School jointly develops, with parents, a School-Parent Compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement. A partnership between home and school is developed to help children achieve the state's high academic standards.

The compact is reviewed and evaluated annually by the Family and Community Engagement Committee/School Community Council and revised as needed. Each child/family receives a copy of the compact which includes information regarding:

- Two-way, meaningful communication through parent-teacher conferences, progress reports, reasonable access to staff, and opportunities to volunteer, participate, and observe in a child's classroom.
- · Opportunities for families to be involved in their child's education.
- · Roles of families, students, and school staff.

As a district that receives more \$500,000 in Title I allocation, the district reserves 1% of which 90% must go to schools with priority given to high-need schools. Information about the allocation of Title I funds will be shared at the Primary School's Annual Title I meeting in September and at the Report to Patrons meeting in October. Families will have input into how the funds are used through the Family and Community Engagement Committee/School Community Council and the Parents' Advisory Meetings (PAC).

Wynne Primary School engages with community resources in order to strengthen school programs, practices, and learning.

- Wynne Primary School collaborates with the K-5 PTA to improve the school and student achievement. PTA leaders are included in district Title I meetings and in the decision-making processes for the school.
- The school collaborates with local mental health agencies to provide programs and services to students.
- The school collaborates with First Financial Bank and the Cara McCollum Birthday Book Club to provide books to students.
- The school obtains resources through grants such as Cross County Community Foundation and other grant sources as available.

Community resources that enhance the instructional program include:

- Farm to You in collaboration with the University of Arkansas, Department of Agriculture Division, SNAP ED Cross County
- Instructional programs provided by Village Creek State Park, Parkin Archeological State Park, KAIT Weather, Wynne Fire Department, Arkansas State University STEM teams, banks, and other local businesses
- Other programs provided by the Cross County UAEX SNAP Ed program
 Wynne Primary School coordinates Family and Community engagement programs with local early childhood programs.
- Parent workshops are provided on reading, phonics, parenting, and kindergarten registration for local area preschool programs.
- Transition conferences are conducted for students entering kindergarten from area preschool programs.
- Tours are provided to area preschool students and their parents/families for students entering kindergarten in the fall.
- The district parent coordinator serves as a member of the Preschool Collaboration for Cross County and participates in Arkansas Children's Week events annually.

Wynne Primary School's Family and Community Engagement Plan and School Improvement Plan are aligned.

Wynne Primary School will build the capacity of parents and families to support student's academic success.

- Two parent-teacher conferences are held annually
- o Fall Parent Teacher Conferences: Nov 9, 2020 @ 3:00-7:30 pm
- o Spring Parent Teacher Conferences: January 12, 2021 @ 3:00-7:30 pm
- A Back to School Night is held in August annually.
- Fall and spring family nights are conducted to provide information to parents about the school's curriculum.
- Mid nine weeks and quarterly progress reports are provided and may be discussed at parent-teacher conferences as needed.
- Students' individual NWEA Map State Assessment results are sent home three times per year.
- Dynamic Indicators of Basic Early Literacy Skills (DIBELS) assessments are used to measure students' reading progress and results are shared with parents.

The primary school will build capacity of school staff to improve student achievement through professional development.

- Teachers will obtain sixty hours of professional development annually including training in literacy, math, and family engagement.
- All Primary School teachers have been trained in R.I.S.E. and all Primary administrators have been trained as R.I.S.E. assessors to ensure effective implementation of the science of reading strategies.
- Family engagement training will include: the value of family contributions, how to communicate effectively with families as equal partners, building ties between home and school, how to provide a welcoming atmosphere, and the process for resolving parental concerns, which is also included in the student handbook.
- The Wynne Primary building level parent facilitator attends community and family engagement training annually and shares ideas with school staff.
- Professional Learning Community (PLC) teams meet weekly to review best practices based on the High Reliability Schools Model.
