Treasurer's Report

Mrs. Cyrus informed the Board of the following:

- We have earned a 2% performance bonus for the 2016 calendar year. We will be
 receiving a check in mail. This bonus is due to joining the local Safety Council and
 attending the required monthly meetings each year and also meeting specific eligibility
 requirements. Congratulations to all staff for being safety conscious.
- Our Transition to Work Program has been approved by Worker's Compensation. This
 will help keep injured employees on the job by placing them in a light duty position until
 they are released by their doctor to transition back to their full duties. Worker's Comp
 will be working with us further on this to complete any necessary forms and procedures.
- We have completed the process of applying for the Worker's Compensation Safety Grant. The safety items totaled \$45,064.80. Worker's Comp will pay for \$33,798.60 and the District will pay \$11,266.20. These items will improve safety, efficiency, and in some cases quality of work. It will still be several weeks before the grant application is reviewed and hopefully approved. We hope to have the items delivered before the end of the school year.
- The Scioto Advantage Clinic is working on setting up a process for the Districts regarding being able to utilize the Clinic for any work related injuries. Any employee can choose to be seen at the clinic for their initial claim and continue care; regardless if they are insured through the health plan or not. This is an added feature to the Clinic which speeds along any referrals that may be needed and also provide immediate care for the employees. If employees can be taken care of at the Clinic and not referred for further care, this results in zero medical claim cost for the Districts, thereby saving on worker's comp premiums.
