**\*\*MONTHLY UNUM LIFE INSURANCE PRICES:**

AMOUNT IS BASED ON DOUBLE YOUR SALARY BUT MINIMUM COVERAGE IS \$30,000 AND MAXIMUM COVERAGE IS \$100,000. YOU PAY .09 CENTS PER \$1,000.

EXAMPLE SALARY-

\$34,990 X 2 = \$69,980 (ROUNDS TO THE NEARTH \$1000)

68 (\$70,000) X .09= \$6.30

**Unum Basic State Public Employee Plan**

- All Employees must participate unless they sign a waiver in Superintendent's Office. Actives pay \$0.09/\$1,000/month. The State pays \$0.09/\$1,000/month for Actives.

**Supplemental State Public Employee Plan**

- All benefits which are optional are paid for 100% by the participant. State pays nothing.
- All coverage guaranteed issued during initial enrollment period.

Active Employees may buy either

**\$10,000 for \$4.00/month**

**\$25,000 for \$10.00/month**

**\$50,000 for \$20.00/month.**

**Dependent Life Insurance**

	<u>Coverage</u>	<u>Monthly</u>
*Spouse:	\$10,000	
**One or more Children:	\$5,000	\$ 5.00
Birth to 6 Months:	\$100	

\*Spouse dependent life will be terminated at spouse's age 70. Coverage may be converted at that time.

\*\*Unmarried dependent children to age 19 or 25 if enrolled as full-time student in accredited school.

**\*\*\* Premiums are paid a month ahead so the first month your premium would be double deducted.**
