- 1) Call to Order President Kruschke called the meeting to order at 7:00 p.m.
- 2) Pledge of Allegiance

Also attending virtually: district staff and residents.
- 4) Report of Meeting Notification and Audio/Video Recording Reminder Superintendent Widiker reported that the meeting was properly noticed and per SCC Employee Handbook, Part I, Section 3.06 (F), he reminded everyone that the meeting was being recorded.
- 5) Welcome Visitors/Public Comment President Kruschke called for public comment with no response.
- 6) Highlight on Youth Nothing at this time.
- 7) Comments by Board Members and Superintendent
 - a. Superintendent Widiker updated the Board on the latest information from School Communication Consultant Joe Donovan.
 - b. The 8th grade Washington, D.C. trip was cancelled this year due to the COVID-19 pandemic. Trip leaders Luke Fritsche and Pat Hook along with the 8th grade staff are proceeding with plans to schedule two Washington, D.C. trips for 2020-21. They are planning a Washington, D. C. trip for next year's 8th graders on May 23rd 28th and next year's 9th graders on June 20th 28th. A stipend of \$1,000 will be available for teachers who chaperone the June trip which is outside their contracted days. Superintendent Widiker commended the staff for working hard to make this memorable trip possible for 8th grade students who missed the opportunity this year.

- c. The school reopening parent survey was shared and reviewed. Kids CARE is ready to open in July. The weight rooms are also ready to open in July with a maximum occupancy of fifteen students at one time. These students will form a cohort and will attend the same timeslot which cannot be shared with another student if the cohort student is unable to attend. The high school is planning for six sessions and the middle school is anticipating three sessions. The school reopening committee is also planning to send out a staff survey to gather feedback on this fall's reopening. Survey questions and inquiries were discussed.

11) Administrative Reports –

a. Student Enrollment Update – An overview of June's enrollment figures was shared with the Board. The last day of school (June 4, 2020) district total increased by one student from May to 1,599 students with an overall decrease of 9 students from last September's total. The open enrollment program net amount continues to be positive with 311 open enrolled "in" students and 107 open enrolled "out" students for a net gain of 204 students. Superintendent Widiker thanked the building office secretaries and district office staff for their hard work in preparing the incredibly important and helpful monthly student enrollment summaries.

b. Update on High School Academic Performance – High School Principal Kurt Soderberg gave a PowerPoint presentation on high school academic performance for 2019-20 including ACT results, CAPP, and Early College Credit program. The SCC ACT five-year average composite score is 21.2. The fall projected composite score for the 2021 class was 20.3 with a final ACT composite score of 21.1. Principal Soderberg broke it down further: 12 students scored 30 or better and 16 students scored 26-29 which calculates to 27% of the 2021 class scoring 26 or higher. He commended the students and staff for their hard work and a job well done. Principal Soderberg also highlighted the Cooperative Academic Partnership Program (CAPP) which is partnered with UW-Oshkosh. The CAPP program gives high school students the opportunity to take quality college courses while in a high school environment. It also prepares a student for a smooth college transition with better study skills and time management. Students pay a third of the cost of the credits. This year there were two CAPP courses offered at SCC: Math 108 - Pre Calculus and English 101 - College Writing. Twenty students participated in the Pre-Calculus class and 38 students in English 101. The CAPP program will be expanding to include two new courses: Communication 111 – Fundamentals of Speech and Math 171 – Calculus. The CAPP partnership with UW-Oshkosh has been very successful and beneficial for SCC students. Principal Soderberg also highlighted: WITC Construction Academy, Youth Apprenticeship program, Start College Now program (CVTC and WITC), and Early College Credits (UW system). Nine students completed the Construction Academy, 36 students participated in Youth Apprenticeship program, nineteen students completed credits in the Start College Now program, and three students took courses through the Early College Credit program. Advance Placement (AP) results will be given at a future meeting. The grading practices at the high school were also reviewed.

 - i. Recognizing the Boys' Basketball team on their Team Academic All-State Recognition.

 - iii. In recognition of Devin Wasley on his Academic All-State Recognition in wrestling.
 - iv. Thanking Amanda Arnold for her outstanding work in creating a combined video of individual SCC Choir students singing the National Anthem and "Granted" for our 2020 virtual graduation ceremony.
- b. Discussion on Future District Needs and Priorities Housing data and in-seat student count information was sent to Hazel Reinhardt for the population study.
- c. Consideration of WIAA 2020-21 Senior High Membership Renewal The WIAA high school renewal was presented for 2020-21. The WIAA Board of Control permanently suspended all

- dues and fees at the 2017 annual meeting. Included in the renewal are nine sports for boy athletes and eight sports for girl athletes. Motion Director DeGross, 2nd Director Olsen to approve membership in the Wisconsin Interscholastic Athletic Association for 2020-21 as presented. Unanimously carried.

Consideration of Approval of Adding Liquidated Damages for Extracurricular Assignments Superintendent Widiker asked the Board if they would like to consider adding liquidated damages to late resignations for contracted extracurricular activities. Much the same as the district's practice of assessing liquidated damages for teacher resignations. Late extracurricular resignations not only put the district in a bind but negatively impacts funding and is unfair to students. This issue was first brought to the Board at the May 18th board meeting. At that time, the Board asked Superintendent Widiker to format the proposal into actual handbook language. The proposed language mirrors the current teacher liquidated damages language in Part II, Section 5.02 Employee Resignations. Middle School Activities Director Langeness gave his perspective on the frequency and impact of late resignations. There was general consensus that this agenda item should be tabled and brought back for a full Board discussion at a future meeting.
- b. Consideration of Board Treasurer to Approve Post-Board Meeting Invoices for July 2020 President Kruschke reported that administration is asking the Board's consent to allow the board treasurer to approve post-board meeting invoices for July 2020 due to no Board Learning and Special Meeting scheduled for July.
