I.	Call to Order The meeting was called to order at 6:00 PM.

III.	Public Hearing A. DEA Representative – Pam Pursell spoke about the challenges that school personnel are working through to prepare for the year and the stress coupled with that, but everyone is working together to meet the challenges. B. Public – No comments		
IV.	Executive Session: The Board entered into executive session at 6:01 PM to discuss the appointment, employment, compensation/performance of specific employees in accordance with 5 ILCS 120/2 (c)(1). The Board returned to open session at 6:34 PM.		
V.	New or Unfinished Business A. Return to Learn Plans for 2020-2021 Mr. Hickam reviewed the plan to open the school year under a blended schedule. A document titled Return to Learn: Essential Information was shared and discussed. In light of the recent decision to allow all students to elect a full-time remote learning option, discussion occurred regarding adjusting the student dismissal time on days of inperson attendance to allow additional time for teachers to connect with remote learners. There was consensus from the Board and administration in support of an adjustment. A document titled Remote Learning Expectations was shared, reviewed, discussed and amended. B. Return to Play Plans for 2020-2021 Mr. Hickam indicated that the high school and middle school would be adhering to the guidelines put forth by the Illinois High School Association and Southern Illinois Junior High School Athletic Association. Accommodations for spectators would be in accordance with the guidelines from the Illinois Department of Public Health. C. Consideration of statement of support/resolution A committee was formed by Mr. Hickam to include high school faculty member LaTasha Baxter along with board members Crystal Harsy and Mark Woodside to work on writing a statement expressing a commitment to be supportive and welcoming towards all families/students.
