All Sutherlin School District families and parents were surveyed for their input on the Spring 2020 distance learning; focusing on challenges and successes. In addition, they were surveyed in regard to preferences and comfort levels to both in person and distance learning for the 2020-2021. It is apparent from responses from both families and staff, while Covid-19 remains a concern, the overriding preference is that students return to the school for onsite instruction. Sutherlin School District is committed to doing what is BEST for our students and community, as such our plan keeps our students at the heart of the plan, decisions are based on what is best for them, and then built around our students. A hybrid model of onsite and distance learning will be used. Full-time distance learning will be available for our families who request it.

Among students in Sutherlin School District:

- 15% of students are with disabilities
- 60% of students receive free/reduced meals
- 19% of students identify as other than white

The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:</p> <ul style="list-style-type: none"> <li>• Communicate with parents and health care providers to determine return to school status and current needs of the student.</li> <li>• Coordinate and update other health services the student may be receiving in addition to nursing services.
