Parent/Guardian Agreement

1. I agree to allow my student to apply to UA-Little Rock.
2. I understand that my student's application is only the first step in the full enrollment process.
3. I have reviewed and understand UA-Little Rock's requirements for admission and registration into concurrent credit courses.
4. I understand that (once enrolled) the financial obligation to UA-Little Rock is the sole responsibility of the parent/guardian.
5. I understand the student cost is \$100 per class in concurrent enrollment courses.
6. I agree to render payment to eStem High School for my child's concurrent credit course(s) by September 11 in the fall semester/by February 12 in the spring semester.
7. I understand that if payment is not rendered to eStem High School by the dates noted above, my child will be withdrawn from his/her concurrent credit course(s).
8. I understand that I will not receive a refund if my child does not pass his/her concurrent credit course(s).
9. I understand my student is required to take AP Exams in all classes where concurrent enrollment and AP are both offered in the same class.
10. I understand my student will not receive credit for the college class on a UA-Little Rock transcript until the college course is completed with a grade of C or better.
11. I understand that graduation regalia chosen at the discretion of the director to designate UA-Little Rock/eStem Concurrent Enrollment graduates is the sole financial obligation of the parent/guardian or student.

Student Agreement

1. I agree to complete all applications and testing requirements for UA-Little Rock by university deadlines to be fully admitted.
2. I agree to enroll myself in the courses of my choosing after being fully admitted.
3. I understand that payment is rendered to eStem High School for my concurrent credit course(s) by September 11 in the fall semester/by February 12 in the spring semester.
4. I understand that if payment is not rendered to eStem High School by the dates noted above, I will be withdrawn from my concurrent credit course(s).
5. I understand that no money will be refunded if I do not pass my concurrent credit course(s).
6. I understand my continuance in the UA-Little Rock Concurrent Enrollment Program is reevaluated each school year, and it is my responsibility to keep my GPA within the accepted guidelines.
7. I agree to take all AP Exams in classes where concurrent enrollment and AP are offered in the same class.
8. I understand that college credit is awarded via a college transcript after the completion of courses, and I must maintain a C average to be awarded this college credit from UA-Little Rock.
9. I agree to return all needed information (signed forms, test scores, etc) to the designated school official in a timely manner to remain a student in good standing in the UA-Little Rock/eStem High School Concurrent Enrollment Program.
10. I understand that graduation regalia chosen at the discretion of the director to designate UA Little Rock/eStem High School Concurrent Enrollment graduates is the sole financial obligation of the parent/guardian or student.
