## **20-21 School Year Assumption of Risk Waiver – Coronavirus/COVID-19 STUDENT**

The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

Milan C-2 cannot prevent you [or your child(ren)] from becoming exposed to, contracting, or spreading COVID-19. It is not possible to prevent against the presence of the disease. Therefore, if you choose to have your child(ren) attend the Milan C-2 School District and its premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

Milan C-2 students will be, from time to time, asked to assist in minor disinfecting processes to further assist in mitigating the potential spread of COVID-19.

**ASSUMPTION OF RISK:** I have read and understood the above warning concerning COVID-19. I choose to accept the risk of contracting COVID-19 for myself and/or my children.

**WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive my right to bring suit against Milan C-2 and its Board of Education, Administrators, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
