Insurance Agreement

Please read this agreement completely, then sign and date indicating your acceptance of the conditions below.

- The insurance policy covers accidental damage and normal wear and tear. This policy does not cover theft or loss due to misplacement. In order for a claim of damage to be “valid,” the student and/or family must produce the remains of the computer for the district to determine if the machine is damaged beyond repair.
- Product failure is fully covered and is not the responsibility of the student, family, or school district. ACVS and its affiliates are the only authorized parties who can classify a defect as product failure.
- I understand that repair and replacement costs associated with instances that are not covered by the school’s insurance policy are the sole financial responsibility of the students and families. This would include: intentional damage, misuse. I understand that assessment and classification of damages (accidental vs. intentional/misuse) are the sole responsibilities of the school district and the school’s findings and determinations are final.
- Students and parents will be held responsible for proper use and care of the laptop computer, as is the case with all school issued materials.

- ACVS provides filtering for inappropriate websites/material. Parents/Guardians are responsible for monitoring their child's use of the laptop when at home to ensure they do not adjust the laptop's settings and preferences or view inappropriate websites/material.
- NO REFUNDS. Even if there is no damage to the laptop over the course of the school year no money will be refunded to you.
- Terms and Explanation of the District's Insurance Policy. This policy covers:
 - With an initial payment of **\$25** full replacement cost for accidental damages (regardless of the age of the computer) with a deductible to be paid by the insured party.
 - Deductible Schedule for Accidental Damage:
 - First incident of accidental damage \$0
 - Second incident of accidental damage \$25
 - Third incident of accidental damage \$50
 - This policy DOES NOT cover:
 - Intentional damage to the computer.
 - Misplacement of the computer.
 - Misuse of the computer (i.e. careless liquid spills, defacing the computer with stickers, ink or paint or other materials, and/or carrying and handling the machine in an incorrect manner).
 - With the exception of manufacturer defect, this policy does not cover theft, loss or damage (accidental or intentional) to the AC power adapter, or any other district issued accessories. It only covers the computer itself.
 - This policy covers the computer for a single school year. Insurance must be repurchased each school year even if the student elects to keep the same computer.
- Having fully read this Insurance Agreement, I understand my responsibilities for caring for and insuring the computer, and I agree to the terms above regarding the laptop computer my student will receive from ACVS.
