See Attached</p> <p>Administration will be in charge of visually screening staff members.</p> <p>Isolation location will be in an office side room. Isolation room is 144 sq ft with room for 1 student and a staff member for supervision. Health room will remain at its original location off of the library, See Attached for Isolation Protocol.</p> <p>Administer and the superintendent will communicate potential COVID-19 cases to school community and other stakeholders. Letters/email is established for communicating with students, parents and staff who may have become in close contact with a confirmed case. See Attached.</p> <p>A system for each staff member of a stable cohorts has been created and will be maintained by each teacher on a daily basis within the classroom. This system has been developed by the school nurse Alena Davis RN in collaboration with LPHA. Policy for recording/keeping of daily logs for a minimum of four weeks. Included in this system is to ensure that school reports are sent for consultation with our LPHA regarding cleaning and possible classroom or program closure if anyone who has entered school is diagnosed with COVID-19. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. COVID-19 symptoms are as follows: <ul style="list-style-type: none"> Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing. Hand sanitizer will be placed by each entrance and required to use prior to student entrance to school and classes, or student will wash hands if unable to use hand sanitizer due to medical issues. Staff are required to report when they have symptoms related to COVID-19. Staff members are not responsible for screening other staff members for symptoms. <p>Ongoing: Weekly letters/emails: Reminders to parents to report actual symptoms when calling students in sick, in part of communication disease surveillance.
