Kelsey Nash, Activities Director, provided information on extracurricular activities increase or decrease in participation and future classification predictions. Mr. Hoey included board recognition by ASBSD, a thank you from Mary House Angel Tree to the Student Council for their participation, and the bus pact helping hand to Elk-Point Jefferson School District.

Cronin moved, seconded by Schweitzer, to approve open enrollment applications #571920024, #571920025 and #571920026. All voted aye. Motion carried.

Roggow moved, seconded by Cronin, to accept the resignation of Lou Ann Adamson as Accounting Assistant effective February 21, 2020. All vote aye. Motion carried.
