Budget Newsletter / May 2020



Dear Northern Adirondack Central School District Parents, Guardians, and Community Members,

On May 18, 2020, the Northern Adirondack Central School District Board of Education adopted a revised budget for the 2020 – 2021 school year of \$23,758, 650. This budget was revised from the proposal that was approved on April 20, 2020 in the amount of \$24,287,699, in an effort to absorb the potential State Aid reductions that have been forecasted by Governor Cuomo to be upwards near 20% of the overall Foundation Aid provided by the State of New York. The approved budget is an increase of \$1,186,525 over the budget that was approved for the 2019 – 2020 school year (\$22,572,125). This increase may seem like a lot, however I hope everyone remembers that during the 2019 – 2020 school year that the District and Board of Education borrowed an additional \$1,500,000 to help pay bills and maintain timely payrolls. There were bills that were paid late during the school year, because of a low cash flow position the District has found itself in. This cash flow or reserve position including fund balance drew the attention of the NYS Comptroller's Office, who placed NAC in a category of being in Significant Fiscal Stress on their Fiscal Stress Monitoring System. Northern Adirondack Central School District is one of four schools out of the reported 674 school districts in New York State that are categorized as being in Significant Fiscal Stress. This report from the New York State Comptroller's Office does not include New York City, Buffalo, Rochester, Syracuse, and Yonkers.

Developing a proposed budget is always a very difficult task, because it should involve long range fiscal planning that maintains educationally sound programming while being fiscally responsible. This year has proven to be extremely difficult in the development of such a budget. One would be safe to assume that an initial challenge would be that I am in my first year as Superintendent of Schools and must obtain the background information, which is true to a certain extent, however I have been a taxpayer by living in the District for nearly 20 years. I have watched from the sidelines like most taxpayers in the past, but now have the inside knowledge to support what I had suspected for many years which is that our tax rates should have incrementally increased over time in an effort to prepare for the unstable years we have had recently and the insecurities we may face going forward. The New York State Comptroller's Office performed an onsite audit that started shortly after I did last summer and concluded in January. The report from this audit has not been finalized and published yet, but will focus on a couple of areas. The major area of focus is related to the first sentence in this paragraph that included fiscal responsibility and long term fiscal planning. The audit report will explain that the practices used by the Board of Education and District over the past number of years were insufficient and not sustainable. The auditors mentioned to me that if the District did not change these practices immediately, then we would soon reach a point of no return and financial insolvency within the next 3 or 4 years. This knowledge helped spearhead an aggressive budget planning schedule, that included public work sessions that were attended regularly by a good number of helpful taxpayers.

Back before the COVID-19/Coronavirus Pandemic put a halt on the school year as we know it, a collaborative effort was embarked upon by the Board of Education, some members of our community, the District Business Manager, and myself. This effort produced an aggressive budget proposal that would have established a strong foundational base to combat the flaws identified by the NYS Comptroller's Office as well as initiating a multiple year plan to establish a secure fund balance with potential reserve accounts. Unfortunately the Pandemic became a reality and Governor Cuomo's projected budget totals in January ended up in an initial shortfall of over \$300,000 to us here at NAC with the imminent possibility of deeper cuts based on three monitoring phases. We have seen slides presented by Governor Cuomo suggesting a 20% decrease in State Aid, but I have also participated in meetings with Assemblyman Jones and Assemblyman Stee who have mentioned potential decreases of up to 40% and 50%. I can only hope 20% is the ceiling, because I believe we can maintain our educational opportunities and staff with our adopted budget that is reliant on State Aid for 62.97% of our overall budget. Hopefully we will receive Federal support, and the potential reductions to our State Aid could be minimized. To put a number to a 20% cut in State Aid from our State Foundation Aid it would be 20% of \$11,132,418 which is a total of \$2,226,483.60 that would be eliminated from our budget. We thought we were going to be provided with information on May 15, 2020 by the Governor's Office, but instead we received no further information that could help us plan for the 2020 – 2021 school budget and it became apparent that schools are being used as a pawn with health care, and first responders in an effort to persuade the Federal Government to pitch in and help out. This is yet another reason why this year's budget planning process has been such a challenge.

- This chart shows that NAC has had the lowest tax rate in Clinton County for many years, which has resulted in losses in programming and an inability to provide the same level of opportunity that our neighboring districts provide to their students.
- The 2020-21 numbers are estimated and become fixed usually in late July, but don't usually change much.
 - Northern Adirondack CSD is the 6th largest school district in land area in New York State at 364.04 square miles or 232,985.6 acres.
 - We are 62 square miles larger than all of New York City, and our buses travel that twice a day.
 - More of our Budget goes in to gas for our buses, not upgrades for our students.



- 2 Uncertified bus lifts in our bus garage, resulting in traveling to Chateaugay CSD with our buses for nearly 3 months to use their lifts, until we fortunately got one certified
- Borrowed a total of \$1,500,000 in two even installments in August and December to pay bills on time and have cash flow to make payrolls
- As a result of low cash on hand amounts the District paid some bills late accruing interest penalties
- Tennis courts have gone another year without overdue resurfacing which may result in completely redoing them in the future
- COVID-19/Coronavirus Pandemic has exposed the District's lack of technology available to students, as well as the need for better Wi-Fi throughout the District
- Governor Cuomo reduced the projected State Aid totals from January by roughly \$300,000, then has the ability to cut the State Aid farther with early projections being 20% or the equivalent to \$2,226,484 to NAC
- NYS Comptroller's Office identified NAC as being in Significant Financial Stress for not having available cash flow, fund balance, or other reserves



Most often wealthier districts in NYS have much lower rates than poorer districts. That's because people who own homes in communities with lower home values and little commercial real estate have to pay at a higher tax rate to generate enough money to cover the same basic services.

The following is a summary of the 2020-2021 proposed budget with comparitive data for the 2018-2019 and 2019-2020 budgets:



Information for Voters

Qualified Voter

A person shall be entitled to vote at any school meeting for the election of school district officers, and all matters that may be brought before such Meeting who is:

- 1) A citizen of the United States of America
- 2) Eighteen years of age or older, and
- 3) A resident within the school district for a period of thirty (30) days preceding the annual vote and election.

Proposition on the Ballot

Resolved, that The Board of Education of Northern Adirondack Central School at Ellenburg be and is hereby authorized to expend the sum of \$23,758,650 total general fund appropriation, and to levy the necessary tax for the school year 2020 - 2021.

Return of Ballots

- Ballots must be received by the District Office no later than 5:00 PM the day of the vote (June 9, 2020)
- Ballots may be mailed or dropped off at the District Office using the designated mail drop slot on the steel door to the right of the glass doors for the District Office.
