

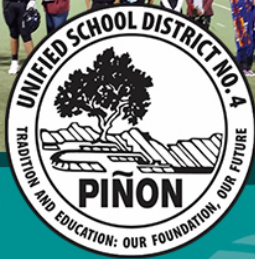

Welcome Back for the 2022-2023 School Year!



Dear Parents & Guardians,

This material is presented to you because your child has indicated a desire to participate in one or more interscholastic extra-curricular activities and you have expressed your willingness to permit him/her to compete in these activities outside the school day. We believe that participation in sports extra-curricular activities provides a wealth of opportunities and experiences which assist students in their personal growth and development. We are concerned with the educational development of students through extra-curricular activities and feel that a properly controlled, well-organized sports and extra-curricular program can meet student needs for self-expression, social, mental, and physical growth.

A student who elects to participate in extra-curricular activities is voluntarily making a choice of self-discipline and self-sacrifice. Failure to comply with the rules of training and conduct means exclusion from the team. This concept of self-discipline and self-sacrifice is tempered by our responsibility to recognize the rights of the individual within the objectives of the team. There is no place in extra-curricular activities for students who will not discipline their minds and bodies for rigorous competition. We are striving for excellence and do not want our athletes to compromise with mediocrity.

Likewise, we feel that you have committed yourselves to certain responsibilities and obligations. We would like to take this opportunity to introduce to you the specific policies that are necessary for a well-organized program of athletics.

It is the role of the PUSD #4 Athletic Department to make rules that govern the spirit of competition for the school. These rules need a broad basis of community support, which is achieved only through communication to the parent(s)/guardians. It is our hope to accomplish this objective through this athletic membership publication for students and parents.

PAPER-WORK CLEARANCE

A student must be cleared through the Athletic Department before he/she can participate in extracurricular activities.

To be cleared for extracurricular activities participation a student must submit all of the following:

1. A valid 2022-2023 Annual Pre-participation Physical Evaluation (AIA forms 15.7- A and 15.7-B)
2. An Emergency Release form signed by the student and parent or legal guardian
3. A student Athletic handbook acknowledgement form signed by the student and parent or legal guardian(s)
4. Parent Permission forms signed by the student and parents or legal guardian(s)
5. A completed Student-Athlete AIA eligibility questionnaire. (for PHS athletes only)
6. A completed AIA Mild Traumatic Brain Injury (MTBI)/Concussion/ Opioid Course Annual Statement and Acknowledgement Form (Form 15.7-C) (PHS Athletes Only)

LETTER TO STUDENT-ATHLETES

Expectations for Excellence

Because of this leadership role, you can contribute significantly to school spirit and community pride. Make Piñon USD proud of you and your community proud of your school by consistently demonstrating your dedication, determination, and pride as a member of Piñon Extra-curricular Activities.

Responsibilities to Others:

As a team member you also bear a heavy responsibility to your home. The younger students in the Piñon community are watching you. They will emulate you in many ways. Do not do anything to let them down. Set good examples for them.

Athletics Department Philosophy, Goals, and Affiliations

Statement of Philosophy:

The Piñon USD Athletic Program should provide a variety of experiences to enhance the development of favorable habits and attitudes that will prepare student athletes to be effective citizens in today's world.

The extracurricular program shall be conducted in accordance with existing Governing Board policies, rules, and regulations. While the Governing Board takes great pride in winning and good citizenship, it does not condone "winning at any cost." It discourages any and all pressures, which might lead to neglecting good sportsmanship and good mental health. At all times, the athletic programs must be conducted in such a way that it is an educational activity.

Athletic Goals and Objectives:

Our Goals – The student-athlete shall become a more effective citizen in society that is learning how to become leaders in the community.

Our Specific Objectives – The student-athlete shall learn:

- a) **To work with others** – To become an effective citizen, a person must develop self-discipline, respect for authority, and the spirit of hard work and sacrifice. The team and its objectives must be placed higher than personal desires.
- b) **To be successful** – Our society is very competitive. We do not always win, but we succeed when we continually strive to do so. You can learn to accept defeat only by striving to win with sincere dedication. Develop a desire to excel.
- c) **To Develop Sportsmanship/Citizenship** – To accept any defeat like a true sportsman, knowing we have done our best, we must learn to treat others, as we would have others treat us. We need to develop desirable social traits, including emotional control, honesty, cooperation and dependability.
- d) **To improve** – Continual improvement is an essential component of good citizenship. As an athlete, you must establish a goal and you must constantly try to achieve that goal. Try to improve in the skills and knowledge required and those personal traits that enhance the success of a team.
- e) **To enjoy athletics** – It is necessary for athletes to enjoy participation, to acknowledge all of the personal rewards to be derived from athletics participation, and to give sufficiently of themselves in order to persevere and improve the program.
- f) **To develop desirable personal health habits** – To be an active, contributing citizen, it is important to obtain a high degree of physical fitness through exercise and good health habits, and to develop the desire to maintain this level of physical fitness after formal competition has been completed.

Athletic Affiliations:

Piñon ATSA Middle School is a voluntary member of ***the Northern Arizona Interscholastic Conference***. As a Member of the NAIC, Piñon ATSA Middle School agrees to abide by and enforce all rules and regulations adopted by the conference. Contest rules shall be governed by NFHS (National Federation of State High School Associations) competition rules in each sport unless otherwise directed by the NAIC bylaws.

Piñon High School is a voluntary member of ***the Arizona Interscholastic Association*** and competes only with approved schools. As an AIA Member, Piñon High School agrees to abide by and enforce all rules and regulations adopted by the AIA.

The primary role of the AIA is to maintain rules and regulations that ensure equity in competition for the student athletes and a balance with other educational programs. The AIA solicits input and is responsive to requests for rule modification from member schools, appointed committees, and coaches' associations.

The AIA attempts to enforce such rules that assure the greatest good for the greatest number of athletes and to ensure that competition is conducted in an appropriate manner. Remember, Pursue Victory with Honor-AIA motto.

Eligibility Guidelines

Athletic Fee:

1. All participants in athletics is subject to an annual \$50.00 fee due prior to the first practice.
 - a) The Athletic Fees will be used to off-set costs associated with events, including (but not limited to): uniforms, officials' fees, meals and other associated costs.
 - b) Athletic Fees are non-refundable. if a student is dropped, quits a team or if a student is scholastically ineligible regardless of participation.
 - c) Parent is responsible for keeping a receipt when paying multiple family members in regards to tracking.
 - d) The Athletic Fee does not guarantee playing time in competition.

PUSD Academic Eligibility Requirements:

The grade check policy is as follows for SY 2022-2023:

1. A grade check will be conducted during each school week on the following days:
 - a) Pinon Accelerated Middle School (PAMS) grade check will be conducted every Tuesday by 8:00 am (Late assignments submitted the day of grade check will not be counted). If a student athlete has one or more failing grades they will be ineligible to compete or travel that week until the next grade check.
 - b) Pinon High School (PHS) grade check will be conducted every Wednesday by 8:00 am (Late assignments submitted the day of grade check will not be counted). If a student athlete has one or more failing grades they will be ineligible to compete or travel that week until the next grade check.
 - c) The end of the quarter grades will count as first week's grade check for the next quarter except during new SY. The beginning of each Semester will begin with a new grading period.
 - d) If a student athlete gets on two grade checks throughout the season, a parent meeting must be scheduled with grade level teachers, coach, athletic director, school administration and student to improve plan.
2. **Academic Eligibility** – it is the coach's responsibility to monitor, enforce, and implement all PHS eligibility rules.
3. **Appeals:**

PAMS will be allotted two appeals per season based on an individual basis. The Wednesday after grade check is the deadline for appeals. In order for an appeal to be approved, all grades must be at a 73.5% or higher.

PHS Student Athletes will not be able to appeal grades throughout the season due to the extension of the weekly grade check.
4. A student athlete must be an enrolled as a student or a home-schooled student within the district boundary.
5. A student athlete must have a grade percentage of a **73.5%** or higher to participate in the week's activities.

6. If a Student Athlete has a **73.4%** or lower in any classes, the athlete will not be able to play for the duration of their ineligibility, however the athletic department encourages athletes to work with teachers (i.e. after school study hall) to become eligible for the next grade check.
7. Student Athletes will not compete in any interscholastic competition until they have met the grade requirements set forth by the PUSD #4 Athletic Department. Although the student athlete cannot compete in games, students must attend after school study hall and then attend practice.

Additional AIA/NAIC /PUSD Competition Rules

1. Student athletes must have 10 practices in before participating in any games/ meets/club activities.
2. Student athletes must be at school/practice the day before, of a game/meet/competition, (and day after a game/meet) unless excused by the Athletic Director and /or Principal. If not excused the student will not compete in the upcoming competition event.
3. Student athletes will have the first two weeks of the season to decide which sport in which to participate. Quitting a team after the first two weeks and joining another team during the same season will not be permitted. Athletes will not be able to join any team during any season after the completion of the first 10 practices of the team.
4. Because of the nature of team interscholastic athletics, where the team relies upon every individual, if a student athlete quits or is dismissed from the team by the coach or an PUSD #4 administrator after the first two weeks of the season, the student athlete will not be able to compete on an any interscholastic athletic team the next sport season (e.g. football season to basketball season) until a clearance hearing is conducted. A clearance hearing committee shall consist of the head coach of the sport the student quit/was dismissed, the head coach of the sport the student intends to join, parents (if requested) the Athletic Director, school Principal, and Superintendent (if needed be). Based on the student's attitude and evaluated level of commitment, a decision will be levied as to whether the student will be permitted to pursue their interest in that sport
5. Athletes will only be able to compete in one sport per season due to the excessive absence from the classroom when a student athlete participates in more than one sport per season. High school athletes may attempt to qualify for state in another sport if permitted by the coach at the end of the regular season and no qualification was achieved by the previous sport.
6. Attendance Eligibility-students must attend all classes on the day of competition. Exceptions must be cleared through the Athletic Office. Violation of this rule will result in a period of ineligibility of no less than one competition.
7. AGE Limits:
 - A. A student who turns 19 on or before September 1st is not eligible to participate in high school interscholastic athletics (AIA bylaw15.1).
 - B. A student who turns 15 before September 1st is not eligible to participate in Middle School interscholastic athletics (NAIC Contest Rule7).

For additional guidelines regarding student eligibility, in regards to transfer student, home-schools students, and other circumstances, please direct inquires to a head coach, the Athletic Director, the NAIC Constitution, and the AIA website (www.aiaonline.org) where a complete copy of AIA bylaws and other documents can be obtained.

Extracurricular Participation Guidelines

1st suspension – Student athlete will not participate in practice or competition during their school suspension. Students will be permitted to return to practice after their suspension has ended and after a meeting with the student, parents/guardians, teachers, principal, coach, and the Athletic Director. The student suspension from the team's participation will mirror that of the school suspension (i.e. 2-day suspension=2 game suspension). No matter what the severity of the school suspension, each player will serve at least a one game upon return to participation.

2nd suspension – Student athlete will be subject to school discipline as stipulated in the school's Student Handbook. Student athletes will not be permitted to participate in any practice or competition immediately following the incident. A discipline committee will convene to determine whether suspension from further athletic/club participation during that season is required. The discipline committee is composed of the school principal, the Athletic Director, the sport head coach. Student may be removed from the team or club with this second offense.

SUBSTANCE ABUSE POLICY

It is the position of the Piñon Unified School District that there is no place for the use of recreational drugs, alcohol, or tobacco in the lifestyle of the student-athlete. The legal consequences for the use of these products by a student-athletes are supported by the Piñon Unified School District. The Athletic Department will follow the district's Zero Tolerance Policy.

Any student involved in the use of or possession of recreational drugs or alcohol may be removed from extra-curricular participation, and disciplinary measures will follow the PHS Handbook.

FIGHTING/BULLYING/INTIMIDATION

To ensure a safe and productive academic environment, fighting, intimidation, and bullying will not be tolerated. If a student athlete engages in any act that is contrary to school policy, they will be subject to discipline from the school and the PUSD Athletic Department. The Athletic Department follows policies and procedures determined by Governing Board Policy JICK on these specific incidents. (Please refer to Governing Board Policies for further information). First offense may result in a ban from extra-curricular activity for the rest of the school year.

SOCIAL MEDIA

Social Media has become such an impactful form of communication with our children, we need to monitor it for their own safety. Only positive responses will be tolerated. Social Media may fall under the category of Cyberbullying and can be cause of school disciplinary actions. Suspension and removal from the team may occur from Social Media responses that target individuals. The Athletic Department follows policies and procedures determined by Governing Board Policy JICK on specific incidents. (Please refer to Governing Board Policies for further information). First offense may result in a ban from extra-curricular activity for the rest of the school year.

HAZING

Hazing is the action or activity which inflicts physical or mental harm or anxiety, or which demeans, degrades or disgraces a person regardless of location, intent or consent of participants. Cases of hazing will be dealt with depending on the nature of the hazing, ranging from harassment (sexual included), to bullying/intimidation, to physical assault with reference to school handbook. Consequence will reflect the above-mentioned steps for fighting/bullying/intimidation. Any form of hazing could result in the removal of the athlete from his or her team. The Athletic Department follows policies and procedures determined by Governing Board Policy JICFA on specific incidents. (Please refer to Governing Board Policies for further information). First offense may result in a ban from extra-curricular activity for the rest of the school year.

TEAM POLICIES

In addition to the guidelines and policies in this Athletic Handbook, there are the policies and guidelines set forth by the coach of each individual sport at Piñon. Each coach may issue a team handbook or policies letter for each sport they coach. The rules may not be less restrictive than the Athletic Handbook, but may be more restrictive. If a coach removes a player from a team for violating team policies with the approval of the Athletic Director, a parent/guardian and /or student may seek mediation and written explanation for the removal from the coach through the Athletic Department.

EQUIPMENT

All athletes will be issued equipment/uniforms at the beginning of the season and will be responsible for maintaining it throughout the season and must return all equipment/uniforms at the end of the season or pay for any lost items. Student Athletes will not be permitted to start a new sport/season until all past equipment /uniforms have been turned in to the Athletic Department.

General Student-Athlete Guidelines & Athletic Department Policies

CONDUCT ON ATHLETIC TRIPS:

All safety rules which are posted on school buses and /or which are stipulated by the coach(s) and /or bus driver must be followed. Student athletes may eat sack lunches or meals provided by the district on team trips and are expected to keep the bus clean. Students athletes are not to leave an athletic event at any time without the consent of the head coach and without parents signing a check-out form. District and school policies will apply to students on athletic trips and students will be subject to school discipline for violations in addition to discipline from the athletic office.

CONDUCT ON OVERNIGHT TRIPS:

Overnight trips are a special privilege for sports teams. Every rule applies like any other trip when it is an overnight trip. Due to student athletes sleeping in rooms together, coaches will need to do routine check-ups on the team. All policies and disciplinary action will be as if the students were in school and will follow the school's handbook. Overnight trips must be approved by the Governing Board.

CONDUCT IN THE CLASSROOM/SCHOOL:

The privilege to participate in athletics is just that- a privilege. It's an advantage, an honor, and a granted opportunity. Participation in extra-curricular activities is not a right. Student athletes who participate in extra-curricular activities are expected to be role models in their behavior and academic commitment in the school. If a student athlete is not conducting him or herself in a responsible manner and are referred to the administration for their behavior, they will be subject to discipline from the athletic office. The Athletic Director, Principal, or Superintendent may indefinitely remove a player from interscholastic competition for disrespectful, irresponsible, and disruptive behavior in the academic environment. A student athlete and his/ her parent/guardians may request clarification and mediation on such an action as outlined in the team policies and appeals section of the student athletic handbook.

EXTRACURRICULAR INJURIES:

Injuries during extracurricular competition and practice are a regretful, but common occurrence. Parents/guardians must be aware of different risks that the student-athlete may be exposed to while participating in each sport. For more information regarding the specific injury risks within each sport, please direct inquires to the coaches of your extracurricular activities. In the event a student is injured during athletic participation it is the responsibility of the student to notify the coaches that an injury occurred. The coach will write an injury report and turn in the paperwork to the Athletic Department. Consultation with the parent, coach, athletic trainer, Athletic Director and a physician (if necessary) will decide the extent to which the student's participation will be limited. If a student is not able to compete due to an injury, the student will be expected to still attend practices and all contests to retain eligibility. If necessary, in order to return to athletic participation, a student must turn in clearance form a licensed physician to the Athletic office and their coach. PUSD is not entitled to compensate for athletic injuries. Athletes are encouraged to buy insurance to avoid medical expenses if injuries due occur during athletic participation.

SPORTSMANSHIP:

Piñon Unified School District is dedicated to the Arizona Interscholastic Associations' pursuit of "Victory with Honor". If a coach or player is ejected from a contest, they will be subject to AIA rules (outlined in 16.3 of AIA bylaws) that will be carried out by the Piñon Athletic Office (Piñon ATSA Middle School students and coaches will be subject to the same discipline). If a spectator does not act in a sportsmanship like manner during an athletic contest, they will be subject to removal from the contest and banned from attending future contest by AIA officials and Piñon USD administrators. Spectators will be expected to take a course (Positive Parenting within School Programs) through NFHSlearn.com before returning to sporting events.

AWARDS:

The awards within the PUSD athletic department are team MVP, Black& Teal, and Most Improved for athletics and any individual awards the club would like to provide to their participants for the year. It is at the discretion of the coaching staff to decide the requirements for each award (or modifications to each award depending on the sport) and who will receive team awards. At the end of each season, there will be an awards banquet(s) to recognize all athletes and accomplishments and an award banquet.

STUDENT EDUCATIONAL RECORDS

(GBP: JR, JR-CA)

This is to inform parents that under district, state, and federal rules and regulations:

- Parents have the right to review their child's educational records at reasonable times;
- Parents have the right to request amendments or corrections to their child's educational records;
- Parents have the right to file complaints regarding the rights given to them and the students under The Family Educational Rights and Privacy Act and the regulations thereto.

(Copies of Board policies concerning student records may be obtained from the District Office or from the Principal's office.)
(Student records may be reviewed and inspected in the Principal's office.)

Family Educational Rights and Privacy Act (FERPA) Model Notice for Directory Information

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Pinon Unified School District, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Pinon Unified School District may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Pinon Unified School District to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with the following information – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

Parent/Coach Relationship

We are pleased that you and your Student Athlete have chosen to be involved with the extracurricular program in Piñon Unified School District. Our goal is to provide a positive experience for all involved. Open communication is the most important factor contributing to this goal. By developing these communication lines, we will be able to resolve questions before they become conflicts.

As a parent/guardian you have a right to know what expectations are placed on your Student Athlete and you as a parent as a fan and spectator at PUSD events. The following is designed to spell out all levels of communication so that parents, coaches, and athletes are aware of the steps they have available to resolve anything they think is or might become an issue.

Procedure to discuss a concern with a coach...

1. Call the coach to set up an appointment.
2. If the coach cannot be reached, call the school office.
3. Please do not attempt to confront a coach/sponsor before or after practice or competition. These can be emotional times for both the parent and coach/sponsor. Meetings of this nature usually do not promote resolution.

Communication you should expect from your child's coach...

1. Philosophy of the coach/sponsor.
2. Coach's expectations for your child, as well as the players on the team.
3. Team requirements, i.e. special equipment, risks of participation, off-season conditioning.
4. Location and times of all practices and contests.
5. Notification of discipline that results in the denial of your child's participation.

Communication coaches expect from parents...

1. Concerns expressed directly to the coach.
2. Notification of any schedule conflict well in advance.
3. Specific concerns regarding a coach's/sponsor's philosophy and /or expectations.

Appropriate concerns to discuss with coaches...

1. The treatment of your child, mentally and physically.
2. Ways to help your child improve.
3. Concerns about your child's behavior.

Issues will not be discussed with coaches...

1. Playing time.
2. Team strategy.
3. Play calling.
4. Other student-athletes.
5. (Parents could have disciplinary action if they are interrupting coaching or talking about any of the above subjects).
 1. (First offense: official written and verbal warning)
 2. (Suspension for one game or any length thereof for the duration of the season)
 3. (Informing the Navajo Nation Law Enforcement of Harassment).

Procedure when a meeting with a coach that does not provide a satisfactory resolution...

1. Call and set up an appointment with the Athletic Director to discuss the situation.
2. At this meeting, the appropriate next step can be determined.
