Dear Parents and Guardians:

We are pleased to announce that Cleveland City Schools will continue to offer meals at no charge during the 2020-2021 school year. We are still eligible for Community Eligibility Provision (CEP) which enables us to extend this benefit to our students.

This will mean that all students receive nutritious breakfast and lunch meals at no cost regardless of family income. As long as your student's school is in the CEP program there will be no need to fill out a Free & Reduced Lunch Application. However, if your student(s) are receiving SNAP or TANF benefits; you will be receiving a Direct Certification Notification letter confirming your benefits.

Please know that your student will receive nutritious meals this school year. We ask that if your student wishes to purchase extra items that you add money to their account either through SchoolCafe or PowerSchool as we strive to keep cash handling to a minimum. We will communicate meal service options if students are not in the school buildings.
